I further acknowledge and agree that there does exist a significant risk of injury that could include the potential for serious injury, permanent paralysis and death. I acknowledge that guidelines, rules, equipment and personal discipline may reduce this risk but that this risk does exist.

In consideration allowing my participation in this event, I hereby release and hold harmless the Arkansas MV Travelers, together with its volunteers, agents, officers and members from any and all liability, claims and causes of action arising out of or in any way connected with my participation in this event or events hosted by the Arkansas MV Travelers with respect to any and all injury, disability, death or loss or damage to person or property, whether arising from the negligence of the releases or otherwise to the fullest extent of the law. This Liability Release Waiver and Indemnity Agreement shall bind my heirs, personal representatives, assigns and all members of my family including any minors.

I understand that the Arkansas MV Travelers reserves the right to refuse any participant, or remove from the convoy/event, any person it judges to be incapable of meeting the requirements of the event, or who it determines to detract from the enjoyment of the trip by others.
