February 10 – March 12 ... Chapters conduct voting for election of local and state delegates.

March 12, 4:00 pm...... Chapters send state delegates' ballots, ballot sign-up sheets and voter verification to Service Center Council by 4:00 p.m. at the SSCC/CTA office located 3900 Mitchell Road, Ceres 95307.

- March 12, 4:00 pm....... SSCC elections committee to count ballots at the SSCC/CTA office, 3900 Mitchell Road, Ceres, CA 95307. Candidates and/or designees may observe.
- March 12..... Announcement of election results to chapter presidents and candidates.
- March 27 ..... Deadline for filing a challenge to the election with the Service Center Council and the CTA Elections and Credentials Committee is fifteen (15) calendar days after the ballots are counted.
- April 6, 5:00 pm ...... Local and state delegate election results must be received by 5:00 p.m. to CTA Elections and Credentials Committee, c/o CTA Governance Department, PO Box 921, Burlingame, CA 94011-0921 or Fax to 650/552-5010 or scanned and emailed to RA@cta.org.
- April 13 ......Delegates who have been elected to both LOCAL and STATE delegate positions must notify the Service Center Council of the position selected. (Delegates may not hold both positions).
- April 20 ...... Service Center Council Chairperson must notify CTA of names of successor state delegates if an elected state delegate chooses to go as a local delegate.

June 1 ...... Deadline for filing an appeal of the CTA Board of Directors decision on a challenge with the NEA Credentials Committee regarding alleged violations of election requirements.
