- **COLLECTION OF PERSONAL AND NON-PERSONAL INFORMATION THROUGH THE WEBSITE**

At FCCI, we value the privacy of our Website and of its visitors, so it is important that you understand the ways in which personal information is addressed on our Website. Personal information collected from you through the Website may include, for example, a name, a mailing address, a telephone or facsimile number, an e-mail address, an occupation, or any other response(s) you choose to provide to questions, or any inquires you may make through the Website. Know that you have control over your personal information when using our Website, and that, except for Content-Specific pages as outlined below, you may browse the pages on the Website without being required to tell us who you are or otherwise reveal any personal information. In other words, the Website only collects personal information when you choose to provide it.

Our Website may collect two types of information: non-personal and personal.

Non-personal information can be thought of as information that does not identify a particular person. Examples of non-personal information we may collect through the Website include, without limitation, the date and time of access, the area(s) of the Website visited, browser type, operating system, host or Internet Service Provider (ISP) and identification of the site from which you may have been referred to our Website. Non-personal information that is collected is utilized for efforts to improve our Website.

Personal information is information that can identify a specific person, and includes information such as a name, address or policy information. However, this information is only collected when you voluntarily supply it. When personal information is supplied to FCCI through our Website, we utilize it only for purposes that are associated with the services provided on or otherwise stated on the Website. FCCI shares information with its affiliated companies but does not disclose non-public personal information collected through this Website to non-affiliated third parties, except as permitted or required by law.

- **CONTENT SPECIFIC PAGES**

Certain pages on our Website may provide content tailored for specific persons. Personal information supplied through the registration process will be kept confidential and we do not disclose that personal information to non-affiliated third parties, except where permitted or required by law. Additional privacy notices may be provided.
