WHEREAS, the Corporate Authorities of the Village of Chapin have determined that it is no longer necessary or useful to or for the best interests of the Village to retain ownership of the following personal property: a 1977 Ford C700 Fire Truck, Serial # C70FVY47435; and

WHEREAS, the Corporate Authorities of the Village of Chapin, Illinois, have determined that the best interests of the Village will be served by selling said motor vehicle.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHAPIN, MORGAN COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: Pursuant to Section 11-76-4 of the Illinois Municipal Code (65 ILCS 5/11-76-4), the President and Board of Trustees find and declare that the 1977 Ford C700 Fire Truck, Serial # C70FVY47435, now owned by the Village of Chapin, is no longer necessary or useful to the Village and the best interests of the Village will be served by its sale.

SECTION 2: Pursuant to Section 11-76-4 of the Illinois Municipal Code (65 ILCS 5/11-76-4), the Village President is hereby directed and authorized to take all necessary action to sell the 1977 Ford C700 Fire Truck.

SECTION 3: This Ordinance shall be in full force and effect from and after its passage and approval in the manner provided by law.
