#### Camping

Camping on the grounds will be permitted.

Porta Johns will be available. We are REQUIRED to haul out our trash and dog waste, close gates, fill in any holes and ruts, spread horse shit and any leftover hay. Please move horse stakes frequently, to minimize impact on the ground. Especially if you are staying for all the field trials in the area. PLEASE be aware this is high forest fire season so do be very careful!

#### Directions

From Highway 260 (from Lakeside/PineTop or Eager Springerville)

Turn North onto Forest Rd 117 – Approximately 3 miles East of Sunrise turn off. Take FR 117 approximately 4 miles to Greens Peak. Turn left onto FR 61 and go past Greens Peak until you cross a cattle guard with a corral on your left. CC Flats Camp turn off is 1 mile from cattle guard. Edges can be soft after heavy rains so be aware.
