**GENERAL GUIDELINES FOR TAMARACK FARM**

**NO TRESPASSING**

**ATTENTION:** Anyone who has not signed a Boarding Agreement and/or a Rider's Release Agreement and/or is not a guest of either a Boarder, Rider and/or Farm Management is TRESPASSING. You are instructed to immediately contact the farm manager for authorized permission to be on the premises. Posting of this notice in the barn &/or at the gate is sufficient notice for all persons.

**UNDER KENTUCKY LAW, A FARM ANIMAL ACTIVITY SPONSOR, FARM ANIMAL PROFESSIONAL, OR OTHER PERSON DOES NOT HAVE THE DUTY TO ELIMINATE ALL RISKS OF INJURY OF PARTICIPATION IN FARM ANIMAL ACTIVITIES. THERE ARE INHERENT RISKS OF INJURY THAT YOU VOLUNTARILY ACCEPT IF YOU PARTICIPATE IN FARM ANIMAL ACTIVITIES.**

**Welcome to Tamarack Farm.** We are hopeful you will enjoy everything we have to offer for both you and your horse. In order to keep everyone (e.g. humans and animals) **safe and happy** while at our facility, we have established the following guidelines that we ask all of you to follow:

1. ASTM approved helmets must be worn by adults and children at all times when on horseback. **No exceptions.**
2. Drive **SLOWLY** on the property!! Please do not exceed 5 mph.
3. NO JUMPING IS ALLOWED by children unless you are in a lesson or you have received special permission from a supervising instructor.
4. Do not ride over the rest of the property without permission. Ask permission each time before riding on the back fields, as conditions or situations may occur that may make the fields unsuitable for riding.
5. Grass areas and grass arenas are off limits for riding when the ground is soft and/or wet. Check with farm management for permission to ride outside designated approved areas.
6. Parking for customers and staff is located next to the barns. Do not leave your vehicle blocking the driveway nor the entrance and exit to the stables or arenas.
7. NO SMOKING is allowed inside the barn or in the close proximity to the barns.
8. Although we love animals of all kinds, please do not bring your dog or any other animal to the farm.
9. Do not leave your horse unattended in the cross-ties for extended periods of time.
10. Always use a lead rope when leading your horse. All halters are hung at the stalls and lead ropes are kept near the grooming stations and at the ends of the aisle ways. Return all halters and lead ropes to their appropriate place when you are finished with them. Only one horse at a time should be led using a lead rope and with halters completely fastened.

11. No running in barns.
12. No gum chewing, or other items in mouth, while mounted.
13. Return all other grooming equipment, supplies and tack to the appropriate place when you are finished with them.  
Each individual is responsible for his/her tack, grooming equipment and supplies. Do not use stable items without the owner's permission. LABEL your personal items for identification.
12. Please pick your horse's feet before taking him out of this stall and when returning to the barn from the arena or pasture. If you forget, please sweep up the shavings, sand or mud in the aisle.
13. Please clean up after yourself and your horse. Put trash in trash receptacles, and all manure in manure buckets.
14. Young children not participating in equine activities must be supervised by a parent or guardian at all times.  
Children may not run and make noise in or around the barn and arenas. Strollers are not allowed in the barn or grooming areas. If there is a non-riding child, sibling or friend who needs a place to play, please ask the farm manager.
15. Non-Tamarack Farm boarders may not ride their own horse or a boarder's horse on the property unless they are in a lesson with an approved instructor, or have received permission from the farm manager, and have signed the Rider's Release and Hold Harmless Agreement.
16. Non-approved Tamarack Farm instructors may not teach or supervise any lessons on the property without special permission from the Farm Manager.
17. Please do not turn your horse out into a field (other than your horse's usual and customary turnout field) without permission.
18. The barns and arenas are open seven days a week from 8 a.m. until 9 p.m. Please let farm management know if you are to be on the farm after hours, and/or are driving a vehicle that is not readily recognizable as belonging to an owner/boarder/rider.
19. No swimming or fishing is allowed on farm ponds, lakes, creeks and/or streams without special permission of the farm manager. Under no circumstances are children to be left unattended near ponds, lakes, creeks and/or streams without parental supervision.  
**WARNING: THE CREEK IS SUBJECT TO FLASH FLOODING DURING RAINSTORMS. AVOID THE CREEK AND SURROUNDING FLAT LAND. UNDER NO CIRCUMSTANCES ATTEMPT TO CROSS HIGH WATER OR A RAPIDLY FLOWING STREAM WHETHER ON FOOT OR ON HORSEBACK.**
20. All special events and activities must be prescheduled with the Farm Manager in order to avoid conflicts and/or inconvenience to other owners and boarders. Farm Management will post a notice in a prominent location in the event of any upcoming special events and/or activities. Furthermore, the event organizer will be responsible for paying all facility fees at least 7 days prior to the event.
