### Minutes of December 3, 2018

The Huntington Township Trustees met in regular session at 7:00 PM at the Township Hall. Meeting called to order with the pledge of Allegiance by Robert Holmes. Also present were Jed Lamb, Walter Rollin, Lyn Ickes, Carl Strekely, Frances Rollin, Dennis Finkel and Sheila Lanning.

Motion by Lamb with a second by Rollin to approve the minutes of the November 19, 2018 regular scheduled meeting as written. Roll call: 3 yeas. Charges and checks (8461-8489) totaling \$22,882.13 were approved for payment. *Motion* by Rollin with a second by Lamb to approve the November financial reports showing year to date revenue of \$399,851.95, year to date expenditures of \$353,199.54 and bank balance of \$302,325.25. Roll call: 3 yeas. *Motion* by Lamb with a second by Holmes to authorize *Resolution 2018-44* amending 2018 appropriations as presented. Roll call: 3 yeas. Motion by Lamb with a second by Holmes to authorize Resolution 2018-45 setting 2019 permanent appropriations budget as presented. Roll call: 3 yeas.

Lyn Ickes presented a draft of the proposed Land Use Survey. Discussion on the length, content and clarification of the draft. Would like the survey back by 1-5-19. Discussion on getting residents to take the time to fill out the survey by offering free trash. Lyn will be at recycle center (2) Saturdays and pass out the survey. Motion by Lamb with a second by Rollin authorizing the survey and providing free trash to those who fill it out. Roll call: 3 yeas. Lanning to make copies for Lyn Ickes.

Holmes reported: Skip Gentry of the Southern Lorain County Ambulance District informed Holmes that Black River schools have already had training. The recycling "hut" is nice and will help to keep the employees warm. Discussion on painting it in the spring. Tree needing trimmed on Bursley Road communicated to the County because it is county road. Attending OPWC meeting 12/7 with Finkel. Webinar on changes in social norms and legislation. Sheriff report for November shows 14 incidents. Exhibit E of the Consortium has been modified. Ordered door prize for LCTA Christmas Banquet, 6 attending. COBRA General Notice received from LC Commissioners Health Care Department. Hording task force meeting 1/15/2019. Put the food delivery project on Facebook again. OTARMA 2018 Capital Distribution expected to be \$638.97. *Motion* by Lamb with a second by Rollin to approve the 2019 agreement with Lorain County Commissioners regarding the Health Care. Roll call: 3 yeas. Asked if Jake brake signs could be used for the 2018 MORE grant. Finkel stated the MORE grant is being used for safety shoes and vest for Snyzal.
