HAGUE WINTER CARNIVAL FEBRUARY 25 - 27

The 17th annual HAGUE WINTER CARNIVAL, sponsored by The Hague Fish and Game Club and the Hague-on-Lake George Sno-Goers Club, with assistance from the Town, will open with a torch-lighting ceremony at Sabbath Day Point at 3 p.m. Friday, followed by a relay run in which the torch will be carried to the Hague Town Beach for appropriate ceremonies.

On Saturday from 7 to 11 a.m. the Hague Fire Dept. will sponsor a breakfast at the Beachside for the benefit of its Ambulance Fund. Registration for snowmobile races will open at 10 a.m. with the races following from II a.m. to 4 p.m. In the DRAG class, there will be races for fan cooled, free air, liquid cooled and modified snowmobiles.

This will be followed by a 50 mile Enduro, (twenty-five - two mile laps.) Entry fees will be \$10.00 for Drags and \$15.00 for Enduro. 50% payback plus trophies.

Activities for the children, including games and relays, will be held on Saturday morning beginning at II a.m. Youth Commissioner Agnes Watts will be in charge and has announced that prizes will be awarded and refreshments served to participants.

On Saturday afternoon a six-mile road run is scheduled on Rt. 9-N from Hague to Silver Pay and return. Awards will be presented following the races. Saturday night there will be a dance at the Beachside Hotel from 9 to 1:30 a.m. featuring country and western music.

On Sunday another breakfast sponsored by the Fire Dept. from 7 to Il a.m.; From II a.m. to I p.m. there will be cross-country skiing; from 2 - 3 p.m. an exhibition by the State Police diving team, and from 3 to 4 the highlight of the carnival - THE NATIONAL ICE AUGER CHAMPIONSHIPS, for which more than 50 entries have already been re-During the day there will be demonstrations of ultra-light airplanes and airplane rides over the lake will be available both days. PUBLIC HEARINGS

ZONING BOARD OF APPEALS - A public hearing will be held on February 24, 1983 at 8 PM for the purpose of hearing a request for a variance from Floyd H. Tyler to construct a 2nd principle dwelling on his property located on the east side of R. 9N and south of Split Rock Rd. Mr. Tyler's lot is 1.02 acres and is located in a TR-I zoning district which requires 1.1 acres per principal dwelling.

PLANNING BOARD - A public hearing will be held on March 3, 1983 at 7 pm on a proposed subdivision of a property known as Terrace View, located on 9N south of Hague Hamlet and also on Dodd Hill Road.

Mr. Dennis Dickerson, engineer for Mr. William Garrison and Mr. Tallia, prospective developers, presented to the Board a preliminary plat plan showing the proposed subdivision in its entirety. The six houses to the front of the property would remain, and the seven small cabins would be removed and three new homes would be constructed on the north westerly portion of the property along Dodd Hill Rd. type of subdivision is allowed in a TR-I area under Section 9,020 of Article 9 of our land use code. section allows the conversion of structures existing on the Date of Adoption of our ordinance that are associated with rental cottages to a single family residential use.)

TOWN COURT

Mr. George R. Van Voorhees pleaded quilty as charged of changing the course of a stream without a permit from the Department of Environmental Conservation before Town Justice Harvey Yaw on Jan. 19, 1983.

He was fined \$250 by the Court, plus \$2.50 in court fees. The Environmental Conservation Officer said that in addition to the fine, Mr. Van Voorhees must take remedial action to restore the stream to its original configuration.

Since February I and until April I, Judge Yaw holds court every Wednesday afternoon at 1:30 p.m. instead of 7:00 pm.

Not bad enough that the environment is threatened by PCB's, dioxin and acid rain. in June 1982 Robert A. Malecki, a Wildlife biologist at Cornell Univ. reported a new menance: the PURPLE LOOSESTRIFE.

He said this beautiful plant (five feet) was so hardy, prolific and aggressive that it was doing in native plants in the wetlands, making acre after acre unfit for water fowl and other wild life. Northeast Beware! ..mb

SAGAMORE PROJECT APPROVED

The Adirondack Park Agency approved the rehabilitation of the 100-yr. old Sagamore Hotel site on Lake George's Green Island in the town of Bolton on January 21; 1983. The APA imposed conditions in its approval relating to solid waste disposal and controlling stormwater runoff into Lake George.

The total project calls for using about 60 acres on the island for the restored hotel: 180 new condominium/ hotel units; tennis courts; an antique boat museum; a lakeside bar-56 boat slips, and other structures. A 250-acre site on the nearby mainland is planned to contain 120 additional condominiums and a rehabilitated golf course. The propected to take 15 years to complete.

This was the headline on Page 1 of the Sports Section of the Times Union, Feb. 6. 1983. Many of our readers have known for some time that Bill Morgan of Silver Bay has been building an unlimited hydro-"Something Else" which is the name of Bill's dream boat, is 28 ft. long, 8 1/2 ft. wide and weighs 4500 pounds. Doug Van Patten, a well-known boat designer from Flint, Mi, spent a year designing this one-of-a-kind boat for Bill. He has hired Cris Ginn of Pickwood, Oh, and Tom Rockey of Seattle. Wa as his two top mechanics. Both have worked on other unlimited hydroplanes such as "United Van Lines" and "Miss Madison".

Bill won't say how fast the boat will go, but "it was only purring" at 140 mph when he took it on its maiden voyage on Lake George two weeks before Christmas. Although Bill hasn't raced unlimiteds before, he has many national power boat races under his belt. One summer he won 36 out of 38 races he entered.

So - next summer when you are lying on the beach and you think you see another Lake George monster - it is probably Bill in his "Something Else." For the first time since 1936, when George Reis in his El Lagarto, having won the Gold Cup races for three years - two on Lake George - raced on Lake George, we again have a contender in our own Bill Morgan. TI FESTIVAL GUILD RECEIVES GRANT

NY State Council on the Arts (NYSCA) recently took favorable action on a grant request for the 1982-83 season. A total of \$4,000 of the \$5,000 grant was awarded directly to the program to subsidize concerts by the Syracuse Symphony, the Greag Smith Singers and the Soviet Emigre Orch. The remaining \$1,000 was to be used for technical assistance to the guild in several areas that NYSCA determined could benefit from some professional expertise.

TOXIC ABUSE

EQUALIZATION COMMITTEE REPORT

At the regular meeting of the Hague Town Board on the 12th of October. Reso-Tution #15 of 1982 was unanimously passed. This resolution requested that the State Board of Equalization and Assessment (SBEA) undertake an independent examination of the full value of all properties in the Ticonceroga Central School District located both in the Town of Hague and Town of Ticonderoga to confirm the inequality that presently ex- . ists in the method used to compute the proportion of school tax payable by the Real Property owners in each Township... and to establish a special equalization rate for the Town of Hague..."

Deputy Executive Director of SBEA, Robert F. Jones responded by letter to Supervisor Bolton on November 18, 1982: "...The 1976 and 1978 market value surveys reflect very substantial market value trends on lake-front property in the Town of Hague. This has brought about full value increases averaging in excess of 13% a year over the last four years as a result of the advancing of the full value standard being used in state equalization rates.

"At the same time, no similar large full value increases have resulted in the Town of Ticonderoga. In fact, the rate of full value increase attributed to the advancing of the full value standard has been less that 4% a year.

"Inequities in the shift in apportionments can only exist, however, if the underlying data of our surveys is found to be incorrect....lacking sufficient evidence to demonstrate inequities exist, such extra surveys are not presently feasible..."

On December 15, 1982, at the regular Town Board Meeting, Supervisor Bolton appointed Alison Craig, William Foster, and Dorothy Henry as a committee to conduct further studies to produce the needed data to prove that inequities in the state's appraisal of full market value do exist as they pertain to the Towns of Hague and Ticonderoga.

The Assessment Review Committee was instructed to present its findings at the SBEA public hearing in Albany on Feb. 2, 1983.

In Decembér, Supervisor Bolton requested from the SBEA its printout of sampled properties in Ticonderoga: it was received Jan. 21, 1983. The Committee examined the state's samples and examined the Ticonderoga assessment rolls: we concluded that the equalization rate did not produce equity in taxation. At.the public hearing in Albany on Feb. 2, 1983 we were told that we had no right to question the assessment practices in another municipality. We were also informed that if International Paper Company wins its suit against the Town of Ticonderoca and the Ticonderoga Central School District, Haque would not have to bear any additional taxes caused by the loss of revenues from IP since this would be the responsibility of the Ticonderoga tax payers, but, Hanue and Ticonderona would both be responsible for the repayment of excess taxes that IP had paid in past years. The IP suit is scheduled to be heard in Plattsburch Supreme Court on April 11. 11983.

Since reporting to the Hague Town Board the above, at the 2-8-83 meeting, the committee has been in contact with the SBEA, the NY State Dept. of Education, Senator Ronald Stafford and Assemblyman Neil Kelleher. Mr. Kelleher has been most supportive and he is scheduling a meeting with Supervisor Bolton, Senator Stafford and the committee to further investigate the allegations of the Town and the committee...ac

THADDEUS KOSCIUSZKO - A HERO

In February Americans honor the birth of Thaddeus Kosciuszko, the Polish military engineering genius. At the age of 30, Kosciuszko met Ben Franklin in Paris and offered his service to the American Revolution. George Washington made him his aide.

At Fort Ticonderoga, Kosciuszko recommended the fortification of the steep and rocky hill, now known as Mt. Deflance. Senior officers disagreed with him and when Burgoyne's army arrived five days later, they hauled guns up that hill and pointed them down on Fort Ticonderoga. During the night the American carrison abandoned Fort Ticonderoga. If Kosciuszko's plan had been followed, the fort could have been defended.

In 1777 he examined the grounds at Bemis Heights near Saratoga, "took a. piece of paper from his portfolio and drew in pencil the plan of the camp... they proceeded to erect breastworks and fortifications." October 17, 1777, Burgoyne surrendered the entire British force of 6,000 troops. Historians have called Saratoga one of the world's most decisive battles. General Gates was celebrated for the triumph. He said. "Let us be honest. The great tacticians were the hills and forest, which a young Polish engineer, Col. Kosciuszko was skillful enough to select for my encampment."

Kosciuszko was chief englneer at West Point which became known as the Gibraltan of America. The British never undertook. to capture it. Some say that West Point. is Kosciuszko's greatest achievement because through strength it prevented battle and bloodshed.

In 1982 the Twin Bridge on the Northway, just north of Albany, was renamed the Thaddeus Kosciuszko Bridge.

PARTIAL TAX EXEMPTION APPLICATIONS are available at the Hadue Town Hall for those senior citizens (65 years of age or older) wishing to apply for a partial tax exemption on Real Property owned by the applicant.

- The owner or owners of the property must all be 65 years of age or older.
- 2. The property involved must be the primary residence and owned for at least two years.
- The total 1982 income of the property owners must not exceed \$5,000 for 1982.

The above conditions must be met and proven to your assessors at the time of filing the original application.

The deadline for filing is May I, ... 1983. If you have been previously eligible for this exemption, you need only apply for a renewal form.

WEATHER OR NOT

Fourteen inches of snow and it is still coming down, with more in the forecast. Winter is finally here! On Jan. 17 a Northeaster dropped 24.5 inches of snow giving us a total of 40.7 inches of snow. Last season there were 57.9 inches while the norm is 49.7 inches. Crently at the stake on Mt. Mansfield in Vt. there are 31 inches; last year at this time there were 91 inches. Rain has fallen washing out much of our possible total snow. However it has snowed all day on the 7th and 8th, so we are looking pretty good again. Water temperature at the 18 in. level is now 35.5°F. Total heating degree day units is now 4009 being 15.5% warmer than the norm at 4784.
