All businesses selling processed foods must obtain a food processor's license from the WSDA food safety program. The Ferndale Farmers Market requires you notify the Whatcom County Health Department that you will be a Food vender at the Ferndale Farmers Market, the Ferndale Farmers Market requires an email confirmation that this was done.
