

**AMELIA VILLAGE, OHIO
Resolution R-2014-03**

A RESOLUTION AUTHORIZING THE ZONING INSPECTOR TO SUBMIT APPLICATIONS FOR COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) FUNDS FOR SPENCER SHANK PARK

WHEREAS, Clermont County administers the Community Development Block Grant (CDBG) funding program for the County; and

WHEREAS, the Mayor has identified the construction of restrooms at Spencer Shank Park as a project that may be eligible for funding through the CDBG process.

NOW, THEREFORE BE IT RESOLVED, by the Council of Amelia Village, Clermont County, Ohio; that:

SECTION II. The Zoning Inspector is hereby authorized to submit an application for CDBG funds for the construction of a restroom at Spencer Shank Park.

SECTION II. Village Council hereby finds and determines that all formal actions relative to the passage of this Resolution were taken in an open meeting of this Council, and that all deliberations of this Council and of its committees, if any, which resulted in formal action, were taken in meetings open to the public, in full compliance with applicable legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION III. That this Resolution shall take effect and be in force at the earliest period allowed by law.


