*Whereas*, the BFI/Republic Landfill located on highway 70 in Ascension parish and near the town of Sorrento is requesting a renewal and major modification from LDEQ (Site ID TD-0050532, AI# 4803, PER # P-0021-R2) and;

*Whereas*, the facility encompasses 287 acres, is in a jurisdictional wetland, in the floodplain, in the 100-year special flood hazard area, in a Conservation zoning district, within one mile radius of 25 domestic drinking water wells and within a three-mile radius of 3,000 residents and; *Whereas*, there have been scores of odor complaints from nearby residents lodged with LDEQ and local

officials citing noxious odors from this landfill and LDEQ has measured concentrations of H2S at seven times the odor threshold outside their fence line and;

*Whereas,* there was a petition filed as a public comment for the permit renewal with over 700 signatures in opposition to this renewal and;

*Whereas*, the new permit would allow the Landfill to expand to 33,000,000 tons and receive Type I Industrial waste, Type II Commercial and Residential waste, Exploration and Production waste and Construction and Demolition waste and;

*Whereas,* the permit renewal/major modification would allow the landfill to build vertically to186 feet Therefore;

*Be It Resolved That,* even though the Town of Sorrento Governing Authority recognizes the need for Industrial facilities to operate in Ascension Parish and recognizes the tremendous benefits received from these facilities and recognizes the need to properly dispose of waste from these facilities along with other waste generated by commercial and residential facilities, the Town of Sorrento Governing Authority opposes the permit application for the BFI/Republic Landfill (AI#4803) for reasons that include: the site's proximity to 3,000 residents, to 25 drinking water wells, the site's location in a Conservation District, in a jurisdictional wetland, in the flood plain and the number of odor complaints lodged from Town of Sorrento residents and That;


