Update on the Canal Dredging Project

You may have been visited by a Brevard County representative who asked you to to sign a waiver so that your canal can be dredged close to your seawall. It's our understanding that if you do not sign, the dredging of muck from your canal will be kept ten feet away from your seawall. But if you do sign the agreement as written, it's our understanding you are accepting liability for any damage the dredging may due to your seawall. Please read the agreement before signing. Also, there is hope that the "Berkeley" canal (between St. Georges and Port Royal) may be dredged after all. It was dropped from the project due to concerns about manatees. Clyde found a new PowerPoint slide from the county that said although the canal "was not part of the original design template" the county "will attempt to add it upon regulatory authorization."
