



**Pearl Lake
CBCW Report
Data as of Aug 21, 2019***

*Note, some data is missing and unrecoverable July 17 - Aug 19)

- 113 inspections hours (85 paid, 28 volunteered**)
- 72 boats inspected
- 173 people contacted
- 100 % of people willing to answer questions:
- 79 % said they had previous contact with a boat inspector, 21 % said they had not
- 94% of people had used their boat in the past 5 days
- Waterbodies they had come from are listed on next page.

Typically a few boats every 4 hour shift; sometimes 0, but usually 2-5 boats per shift. This year has even less traffic than normal, due to the high water and wake restrictions.

*Some data is missing an unrecoverable, due to the unexpected departure of Sparky, the 2nd boat inspector to leave the program this summer. We have not been able to recover the data sheets that she had not yet entered.

**Volunteered hours have been properly documented, so *should* be accepted as in-kind match.

Remaining shifts through Labor Day are scheduled with other inspectors: Sam Coates, Madeline Abbatacola, and Bob Gustison (a Big Hills Lake resident).

CBCW grants are now able to be split with a 2nd lake. With low boat traffic on Pearl, it may be reasonable to split a grant (and the costs) with another nearby lake that also has low traffic.
