#### Walk-through & Warm-up

A warm-up area, consisting of a regulation agility jump, will be provided. Umbrellas are not allowed on the course during the walk through.

#### **Classes Offered**

All levels of Standard STD, JWW, FAST and T2B, including the preferred classes, will be offered according to the entry form. The highest combined score from the STD and JWW rounds for small (8" & 12"), medium (16" & 20"), and large (24" & 24C") dogs in the regular classes, and small (4", 8" & 12") and medium (16" & 20") dogs in the preferred classes, will win. Qualifying scores in both classes are required to be in contention. Scoring is based on the highest combined YPS.

# HIT winner will have a choice of the HIT clothing items or a weekend's free entry—3 runs per day for three days.

All prizes will be awarded during the trials and none will be mailed. Awards will only be given for qualifying scores. A rosette and jump bar will be offered to any dog completing a MACH or PACH at these trials.

#### Dogs Eligible to Enter

This trial is open to all dogs 15 months of age or older that are registered with the American Kennel Club or are register-able breeds that have obtained PAL/ILP numbers from the American Kennel Club, except bitches in season, aggressive dogs, blind, or dogs suffering from any deformity, injury or illness which may affect the dog's physical or mental performance. **Mixed breed dogs** listed in the AKC Canine Partners program are eligible to enter this all-breed AKC agility trial. Mixed breed dogs entered in these events must list the breed name as "Canine Partner" (mixed breed) and not as a breed hybrid and must include their AKC Canine Partners number on the entry form and check the AKC No. Box.

#### Important Information for Exhibitors

- All owners and handlers are responsible for correctly entering and participating in this trial in accordance with AKC rules. Owners are responsible for errors in entry forms, regardless of who may make such errors.
- All dogs must be on leash at all times except when in the ring or when in the designated agility warm-up area. AKC does not permit pinch/prong collars, electrical or special training collars anywhere on the trial grounds.
- The safety of dogs is of primary concern. By entering the trial, exhibitors acknowledge that they are familiar with the rules and regulations of the AKC agility program, and that their dogs are familiar with and able to perform all obstacles safely.
- Confirmation of entry and a schedule of judging time will be sent to the address (email will be used when provided on the entry form) on the official AKC entry form after the closing date. If an exhibitor has not received a copy of the schedule at least seven days prior to the show, the trial secretary should be contacted. Returned checks do not constitute a valid entry. If measured by the Judge of record, that measurement will be valid for this trial or back-to-back trials only.
