## ORDINANCE NO. 21-06

# AN ORDINANCE TO AMEND CHAPTER 21-2-8 LIQUOR ARTICLE II - LICENSES OF NEWTON CITY CODE

BE IT ORDAINED by the City Council of the City of Newton, Jasper County. Illinois that 21-2-8 Outside Sales be and hereby is amended as follows:

21-2-8 **OUTSIDE SALES.** Any license holder desiring to serve alcoholic beverages for consumption outdoors, must construct and maintain a wall or fence having a minimum height of four (4) feet and which surrounds the entire area. Said wall must be located a minimum of six (6) feet from any public sidewalk. The plans for said wall or fence must be approved by the City Council prior to the wall or fence construction.

Except as amended hereby, ARTICLE II shall remain in full force and effect according to its original terms and amendments thereto.

This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
