Ordinance O-2019-04

AN ORDINANCE INCREASING DUSTIN WADE HOURLY RATE AS A POLICE OFFICER FOR AMELIA VILLAGE AND DECLARING AN EMERGENCY

WHEREAS, The Mayor of Amelia Village, after conferring with the Police Chief, has recommended that after the completion of the probationary period of Dustin Wade as a full-time police officer for Amelia Village, that he receive an hourly wage increase; and

WHEREAS, The Council of Amelia Village concurs that Dustin Wade should receive an hourly wage increase for his work as a full-time Amelia Village police officer.

NOW, THEREFORE, be it ordained by the Council of Amelia Village, Clermont County, Ohio, that;

SECTION I Dustin Wade, who is employed as a full-time police officer of Amelia Village and has completed the required probationary period, will receive an increase of salary to \$18.84 per hour effective January 21, 2019.

SECTION II Council hereby finds and determines that all formal actions relative to the passage of this Ordinance were taken in an open meeting of this Council, and that all deliberations of this Council and of its committees, if any, which resulted in formal action, were taken in meetings open to the public, in full compliance with applicable legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION III That this Ordinance is hereby declared to be an emergency measure for the preservation of the public peace, health, safety and general welfare of the Village. The reason for such necessity is to ensure timely payment to Officer Dustin Wade who has completed his required probationary period. Therefore, provided this emergency clause receives the affirmative vote of a supermajority of all members elected to Council, this ordinance shall take effect and be in force immediately upon its passage at the earliest period allowed by law.

MR. FISCHER moved to suspend the rules requiring two readings on two separate dates.

MR. HACKER seconded the motion.
