#### A. Freddy Partida (Special Use Permit for Old Taylor Forge Property)

#### B. Allen Modlin/Austin Hess (Special Use Permit for 901 S. Oak Street)

Discussion was held about above stated property. Residents who live in nearby properties discussed with the commissioners about their concerns as to whether taxes will go up, whether property will be maintained properly, increased danger to children due to the streets becoming busier, what type of fencing, where will the entrance be and if there is another property the business could be located instead of next to residential. Gary Giczewski (Zoning Administrator) assured them the business would have to comply with state regulations and city ordinances. The Commissioners questioned whether there will be fluid runoff, will that create issues and who is responsible for that, as well as overflow of vehicles, and what the capacity of the tow lot is.
