

### **COVID-19 Health and Safety Plan**

#### Illness

- Please, do not come to the studio if you or a family member have a cough, fever or are sick.
- Please, do not come to the studio if you have tested positive, or have had COVID-like symptoms, within the past 14 days.
- Please, do not come to the studio if you had close contact with a person who has tested positive for COVID-19, or has/had COVID-like symptoms, within the past 14 days.
- We reserve the right to take temperatures of anyone entering the studio using noncontact, infrared thermometers.
- Anyone with a temperature of 100.4 °F, or above, will be asked to leave the studio.

#### Students

- Students must come dressed and ready for class.
- Students cannot change clothing anywhere within the studio.
- Students should bring the absolute minimum inside the studio. Only what is needed for classes that evening.
- Students should bring their own water with a resealable lid and name clearly marked. Water will be available for sale (\$1) at the front desk.

#### **Face Coverings**

Due to Pennsylvania's Universal Face Coverings Order:

- Everyone 2 years old, and older, must wear a face covering.
- Face coverings include any mask, shield or covering of both the nose and mouth.
- Students are not required to wear face coverings while actively engaged in dancing.
- Students can place their face coverings inside their bags while participating in class. All
  personal belongings will be taken into classrooms.
- Students must wear face coverings while in the lobby, entering and exiting the dance rooms, bathroom, and anytime 6 feet of social distancing is not possible.
- Students who prefer to wear a face covering while actively engaged in dancing may do so.

# Lobby / Studio

- The lobby/studio will be limited to students, faculty and staff.
- All parents/guardians, siblings and family members must wait outside of the lobby/ studio. \*We are reviewing our plan for parents of combo and beginner students.
- Everyone entering the lobby/studio must use hand sanitizer.



#### Classes / Classrooms

- Due to social distancing, individual class sizes will be strictly limited to each classrooms capacity taking into consideration 6 feet of social distancing. Registration will be available only on a first come, first served basis.
- Classes will be shortened for dismissals and cleaning:
  - 45 minutes classes will now be 40 minutes;
  - 60 minute classes will now be 50 minutes.
- Students must abide by their "assigned" marked social distancing area for that day's class.

#### Restroom

- Students should go to the restroom before coming to Generation Dance.
- The restroom will be limited to students, faculty and staff.

All frequently touched surfaces will be cleaned after every class.

# Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people.

Generation Dance has put in place preventative measures to reduce the spread of COVID-19; however, Generation Dance cannot guarantee that you or your child(ren) will not become infected with COVID-19. Further, attending Generation Dance could increase your risk and your child(ren)'s risk of contracting COVID-19.

I understand that the risk of becoming exposed to or infected by COVID-19 at Generation Dance may result from the actions, omissions, or negligence of myself and others, including, but not limited to, Generation Dance employees, volunteers, and program participants and their families.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)'s attendance at Generation Dance or participation in Generation Dance classes. On my behalf, and on behalf of my children, I hereby release, covenant not to sue, discharge, and hold harmless Generation Dance, its employees, agents, and representatives, of and from the claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any claims based on the actions, omissions, or negligence of Generation Dance, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any Generation Dance program, class or event.
