Even though the National Convention is over, it is not forgotten. It was busy, informative, fun and well attended. North Dakota was represented by 27 delegates. When alternates, chaplains, husbands and others were added in, the total ND representation came to 42! I thought that was impressive. It was good



to see our National Board in action and get to know them a little. Our new National Regent, Shirley Seyfried, is from Minnesota and will do a fine job...just as Anne Nelson, the Immediate Past National Regent did.

During this time between convention and workshop, I have had a little time to more carefully look over correspondence that came in during the summer. I appreciate so many courts getting their financial reviews completed and mailed to me without having to be reminded. Looking at the financial reviews, however, raised

some concerns. I noticed that some courts listed current funds of \$5,000 to as much as \$11,000. When I looked at their total amount paid out by check for Religious, Charitable, and Educational purposes the totals were in the \$500 - \$900 range. I find it admirable that courts are able to raise those large amounts of money, but why are those funds being held on to so tightly? Please remember that Catholic Daughters is all about Unity and CHARITY.

It was truly touching to see how grateful the representatives from various national projects and charities were when our donations were presented to them. Your donations to these projects and charities really do make a difference in people's lives. And I know that you all donate to charities and worthwhile organizations around the state and in vour community. So again, please remember the purpose of Catholic

At the 55th National Convention, the Bylaws Committee presented 32 proposed amendments to the bylaws. Of these, 26 passed,

two failed, and four were withdrawn. 27 resolutions were submitted to the Resolutions Committee. Of these, five passed, two failed, and 20 were not discussed (as they were specific to Local Courts). More on these can be found on the National CDA website - and will also be covered at State Workshop in October. A bylaw is a 'rule' that governs the internal affairs of the organization - bylaws must be followed.

A resolution is a 'suggestion' that was discussed and passed at a convention - each Court may decide whether they want to follow any given resolution. One of the bylaw amendments submitted by the National Bylaw Committee and passed concerns Local Courts.

Article XII Local

Courts Sec. 7. Duties of Local Court Officers

A. The Regent Shall:

10. Insure that the following documents are provided to the District Deputy/<u>State Supervisor:</u> a.) All minutes of the Court meetings. b.) All Treasurer's reports c.) Annual Court budget d.)

Semi-annual financial reviews e.) Court program book (list of officers) f.) Court newsletters (if Court has one) g.) Court standing rules h.) Other correspondence as requested

Rationale: This will help the District Deputy/<u>State Representative</u> be aware of what is happening in the Courts under her jurisdiction and be better available to provide assistance with issues that may arise in the Court. **ND has State Representatives, not District Deputies.*

Each Local Court should have a set of bylaws; updates are sent out by National. Please take the time to look through and follow their guidance.

- We should think of this at our court meetings. Where is Jesus? Is He in the midst of our meetings?


- WE are called to bring WHO we are to others. We are service people.

July 12, 1935–June 6, 2014

Margarete Senger, 78, Linton, ND, passed away June 6, 2014 peacefully in her home, surrounded by family after a four month battle with cancer. Services were held at 10 a.m. Wed., June 11, 2014 at St. Anthony's Catholic Church, Linton, ND with Rev. David Richter officiating. Burial was held in the church cemetery.

Margarete was born July 12, 1935, in Selesia, Germany, to John and Maria (Fesser) Morcinek. There she lived until she was nine years old. Her biggest memory of the war is of the time her mother, four siblings, and grandmother, plus a neighbor lady and her mother, left by wagon and oxen to evade the Russian Army. They headed west for two days, but the two grandma's refused to go on, and they turned back, only to be met by German soldiers who moved the family out by train, to Bavaria, West Germany.

After meeting the love of her life, Margarete married Raymond Senger, on May 26, 1955, at the Air Force Chapel in Germany. Together they established their home, farming east of Linton, where they raised five children. They moved into town in 1990.

Margarete belonged to Catholic Daughters of America, the Legion Auxiliary, Senior Citizens, Homemakers, and bridge clubs. She was also song leader in the church choir. She was a great hostess, who enjoyed having her family over and fixing large holiday meals. Margarete also loved to knit and crochet. She took pride in making blankets for her grandchildren and other family members.
