BRANCH MEETING November 18, 2020

The meeting started with discussion and approval of the October Minutes. Shipmate Rauch made a motion to approve, Shipmate Gunther seconded and all approved.

Next on the agenda was the Report of Committees. Youth Activities, Shipmate Kaider reported the Gaithersburg High School NJROTC Veterans Day Ceremony on November 11, 2020 was postponed because of weather and was rescheduled for November13, 2020, but was unable to attend.



Now I rest beneath the waves, embracing my beloved crew - Almost the entire complement, One Thousand One Hundred and Two.


Though our worldly days are over, don't for a moment be misled, the spirit within me is STILL ALIVE, kindled by the GALLANTRY of my dead.

TRICARE and FEDVIP Open Season

TRICARE Open Season:

- Prime and Select Enrollees may switch benefit plans during open season from November 9 through December 14, 2020. If you choose to do nothing, your plan will remain the same for the next year. Remember, you can only change between Prime and Select Plans during Open Season or with a Qualifying Life Event. Learn more by visiting tricare.mil/openseason2020.
- Note: Are you a Group A retiree or family member enrolled in TRI-CARE Select? If you or your sponsor's initial enlistment or appointment occurred before January 1, 2018, you are in Group A. Act now to set up payment for a new monthly TRICARE Select enrollment fee to keep your TRICARE Select coverage. These fees go into effect Jan. 1, 2021.
