The only other change to the 2018 budget as compared to the 2017 budget was to eliminate the \$200 "Management Services" line item as Anoka County will be providing these services to the coalition at no cost. Legislative Update: Rep. Nolan West (District 37B) discussed the legislation he introduced (HF 1496) asking for \$600,000 for a corridor study on TH 65 from County Road 10 in Spring Lake Park to Bunker Lake Boulevard in Ham Lake. MnDOT staff in attendance noted that they will be developing a project to do this in 2018 even though the legislation was never received funding.
