RGVPAS 3rd Annual CME Conference

Established in 2018, the Rio Grande Valley PA Society has made great efforts to promote and advance the PA and NP profession in the Rio Grande Valley area. RGVPAS is excited to host the 3rd Annual CME Conference on October 30th - November 1st at the DHR Convention Center in Edinburg, Texas. In past years, the conference has attracted over 100 PA and NP attendees from all over the RGV area as well as the South Texas area. Each year's event has centered around informative speakers and a connective Exhibit Hall, where all breaks and receptions bring attendees and exhibitors together.

PA & NP FACTS

PAs have more than 400 MILLION patient interactions per year.

87.1% of **NPs** are certified in an area of primary care, & 72.6% of all NPs deliver primary care.

131,000 **PAs** currently reside and work in the U.S. 36% in hospitals; 5.9% in urgent care; 53.3% in outpatient office or clinic; 4.3% other.

95.7% of **NPs** prescribe medications, & those in full-time practice write an average of 20 prescriptions per day.
