The Rules of Golf.....Continued

Ball Unplayable Rule

The player may deem his ball unplayable at any place on the course, except when the ball is in a water hazard. The player is the sole judge as to whether his ball is unplayable.

If the player deems his ball to be unplayable, he must, *under penalty of one stroke*:

- a. Proceed under the stroke and distance provision of Rule 27-1 by playing a ball as nearly as possible at the spot from which the original ball was last played (see Rule 20-5); or
- b. Drop a ball behind the point where the ball lay, keeping that point directly between the hole and the spot on which the ball is dropped, with no limit to how far behind that point the ball may be dropped; or
- c. Drop a ball within two club-lengths of the spot where the ball lay, but not nearer the hole.

If the unplayable ball is in a bunker, the player may proceed under Clause a, b or c. If he elects to proceed under Clause b or c, a ball must be dropped in the bunker.

When proceeding under this Rule, the player may lift and clean his ball or substitute a ball

Reminders.....

- ◆ All Golfers – Please do not start at a tee other than hole number one without checking with the Clubhouse staff.
- ◆ Walkers – Please check in with the Clubhouse staff before starting play.
- ◆ Players making the turn from 9 to 10 alternate with players starting on hole 1.
- ◆ No more than two players & bags per cart. Must be 16 years or older to drive cart.
- ◆ Each player must have his own bag & clubs. (Two people cannot play from the one bag).
- ◆ Course Closed Sign – if the course closed sign is up, the course and putting green are closed to all play including walkers. If the clubhouse is closed but the course closed sign is not up, members are permitted to walk.
- ◆ Please repair divots and ball marks
