AN ORDINANCE ESTABLISHING SUPPLEMENTAL
STANDBY CHARGES TO DEFRAY ORDINARY
OPERATION AND MAINTENANCE EXPENSES AND
TO PROVIDE FOR THE LEVY AND COLLECTION
THEREOF

BE IT ORDAINED, by the Board of Directors of the McKinney Water District,
Placer and El Dorado Counties, California, as follows:

1. An annual supplemental standby charge to defray ordinary operation and maintenance expenses, commencing in the fiscal year beginning July, 2008, in the amount of Eighty and 00/100 Dollars (\$80.00) per parcel, as shown on the last equalized County assessment roll, and to which water is available, regardless of area, is hereby established and is payable by holders of title to land to which water is so available, whether water is actually used or not.
2. The supplemental standby charge herein established is in addition to those charges previously established by Ordinance No. 1976-1.
3. Pursuant to the provisions of sections 35479-35481 of the Water Code of the State of California, the Counties of Placer and El Dorado, respectively, shall levy and collect the supplemental standby charges herein established in the time, form and manner as provided in said sections.
