Interviews with the Livestock Committee will be conducted 11/12/24. If you submit a complete application, you will receive an email prior to 11/12/24 asking you to be present for interviews. The Jr. Committee will be limited to a maximum of 10 members; however the Livestock Committee will make selections at their discretion based on application quality and merit and may select less than 10 qualified candidates to form the Jr. Committee.

- Attach one letter of recommendation
- Be available to attend interview – all applicants who submit complete applications will be interviewed

### Jr. Livestock member requirements are as follows:

Must be in 6<sup>th</sup> grade and up

Must be a current VVF exhibitor

Must be willing to help with any and all aspects of the VV Fair and preparation leading up to it

Must demonstrate leadership skills, set a good example in and out of the show ring, and be willing to learn new things

Must pay a \$5 annual membership fee
