# River Access Fees Update Great News! Courtesy of Bill Tanger

River friends, boaters, conservationists, fisherfolk, etc:

### We have won the battle to repeal the noxious river access fees!

Thanks to all who helped, especially those who contacted their legislators!

As you know, in 2021, FORVA got the fees put on hold for a year.

On January 18, 2022, my senator John Edwards (D) brought our repeal bill before the Ag & Nat Resource committee. It was supported by a vote of 15 to 0.

Then it went to the full senate and was supported by a vote of 39 to 0.

My state delegate, Terry Austin (R), sponsored the repeal bill in the house of delegates. On January 26, the bill was supported by the House Subcommittee on Ag and Nat Resources by a vote of 20 to 1. (The one vote was Matt Fariss (R) of Lynchburg.)

Then it went to the full House and was supported by a vote of 92-7. (1 Demo/6 Repubs)

#### The governor signed the repeal bill on April 11. Success! No more fees.

This could not have been done without the huge support of FORVA, the Float Fishermen and many others who took the time to reach out to their legislators.

I encourage you all to reach out again to thank your legislators for their support... and in case they did not support, to so note for the next election.

### Blackwater River Dam Removal: FORVA dambusting again!

On April 25, 2022, FORVA demolished the Altice Mill Dam on the Blackwater River. The dam, 110 feet long and 6 feet high, was built as a grist mill in 1916 and ceased operations in 1935. It had been a barrier to boaters and fish, and a safety hazard requiring a portage.

All material from the dam removal was used to restore the riverbank just below the dam's former location, which was extensively eroded over the years. This material included rock and concrete from the dam and sediment from upstream.

The project was initiated by FORVA, who provided project management, landowner outreach and permitting, with the assistance of the U.S. Fish & Wildlife Service (FWS), the Creek Freaks of Franklin County, and the property owner.

The dam had been a barrier to fish migration for over 100 years. The property owner has already observed fish moving upstream of the dam, including smallmouth bass.

The dam removal will increase recreational use, and kayakers have already floated through the old dam site, now a class one rapid. This dam removal on the Blackwater River will also contribute to FORVA's efforts to create a Franklin County Blueway, now starting up, which includes both the Pigg and Blackwater Rivers.

A trip on the Blackwater is planned. FORVA continues with dambusting projects! Contributions accepted!

## **Back Creek/Douthat Trip Courtesy of Rick Mattox**

April 1 to 3 was our annual trip to Douthat State Park for the primary purpose of paddling Back Creek that Saturday. Back Creek is somewhat unique in that both sides of the section we paddle is owned by the Boiling Springs Rod and Gun Club requiring written permission from the club. Despite any opinions regarding riparian ownership of a river, the club has been very generous for the past 40+ years in granting FFV permission.

Rock Willoughby and I took advantage of a bonus opportunity to paddle the Bullpasture Gorge on the way to Douthat that Friday. The cold rain and snow (and sleet) did not deter the excitement and opportunity to paddle that section of river. That section is four miles of mostly class 1 to 2 rock garden/ledge type rapids. It then narrows through the gorge and a couple of class 2 to 3 ledge type rapids. Fortunately for us, there was no carnage along the way. The Bull was running just below 200 CFS, which is probably close to a minimum flow for paddling.

Our group consisting of Bomar, Rock, Bill Powell, Tony and Taylor Adams, Vera Houghton and myself converged on the Douthat Main Lodge. John and Amena Burton were also there staying in a separate cabin. The Douthat Lodge is a 6-bedroom log lodge on top of the park overlooking the lake in the distance. Ironically, while there was water in the rivers, there was no water in the lodge. The well pump broke shortly after our arrival. As you might imagine, 7 people staying in the lodge without water, showers, working toilets added an unanticipated twist to our adventure. Hats off to park ranger Derek who bent over backwards to help us get through the weekend bringing 2 large coolers of water to wash dishes and flush toilets and 2 cases of drinking water. He was also around until 10 or 11 each night working with the electrician trying to fix the problem. For the benefit of all staying in the lodge, we were able to take showers at the nearby camp ground. We finally got water about 11:00 Saturday night.

On Saturday, Vera, Bomar, Tony, Taylor, John, Rock and myself paddled Back Creek. It was running about 250 CFS. Back Creek is a beautiful stretch of river with rock cliffs on both sides. It is about 6 miles of mostly class 1 to 2 rock garden type rapids with a couple of class 2 to 3 ledges along the way. There was no carnage with the possible exception of Vera having a run-in with a rock and the rock prevailing. She did an efficient self-rescue and all was good.

Rock, John and I have been doing this trip almost annually for over 40 years now. It is always one of the paddling highlights of the year.

## **Canoe/Kayak Fishing Tips Courtesy of Bryon Jones**



River Fishing is Fun

- 1. 16 and over must have a fishing license.
- 2. Prepare your canoe paddles, floatation etc.
- 3. Beginners should always fish tandem with a guide makes catching easier and safer.
- 4. Check gear for the fish you are after. Don't over think or pack. Fishing Gear doesn't have to be expensive I have used a \$19.95 Shakespeare for years. Select good bait and artificial lures. Needle nose pliers, nail clippers, and first aid kit always a must.
- 5. If fishing solo learn how to hold fishing rod in one hand and paddle in the other. Trees often catch your bait.
- 6. Pay attention to River and conditions on the River. Rapids and rocks often cause mishaps while canoeing.
- 7. Learn where fish like to hide.
- 8. Be quite while fishing fish have ears LOL.
- 9. Catch and release.
- 10. Keep that line tight.

Remember they may not always be biting or it would be called catching not fishing.
