Expenditures are under budget at 68\% and revenue slightly ahead at 99\%. Mostly from interest and taxes. Interest is still up. Unrestricted Funds at \$3,552,772.36 and Restricted Funds at $\$ 931,239.48$ for a Grand Total Fund Balance of \$4,484,011.84.
When do we get the beer \& wine tax?

Scott: After the end of the year, in July. We were very close on our property tax estimate.
