Travis Ferguson brought a motion forward that sponsors should be allowed to set up a vendor to benefit the membership on race weekends

Board motions to be put forward:

Brent brought forward changes to By-laws

Section 1 Membership - Changes to article B

B. An annual membership enables the holding member access to all organized MDR events as well as voting privileges at the annual general meeting.

Change to read: An annual membership enables the holding member access to all MDR events. A non-competitive membership is for immediate family members of competitive members. Voting privileges are reserved for persons who hold an annual membership and have competed in at least one MDR event, or people with non-competitive memberships with an immediate family member who has competed in at least one race for that season.

Voted – All in favor - Passed

Changes to article F – A weekend pass for persons not wanting a seasonal membership will be available on the weekend of an event. These passes are non-transferable weekend passes that permit the holder to enter the event held on that weekend only.

Add: no points will be accumulated or transferred for events competed in under a weekend pass.

Voted – All in favor – Passed

Changes to article G - Non-competitive enthusiast memberships will be available for riders wishing to be associated in non-competitive events

Remove as its been added to B

Non-voting advisor - volunteer position - All in favor - Passed

Section 3 – past president's position:

X: add Past President. The Past President provides advice and leadership to the Board of Directors regarding past practices and other matters to assist the Board in governing the Association. The Immediate Past President performs the duties of the President in the absence or disability of the President. This position will rotate as soon as the current president steps down or is voted out. Section 3 – Article Y – You have to be an active competing member to be on the board but you can be granted a 1yr medical exemption – All in favor – Passed

Section 9. A - Classes

Junior B – change engine displacement to 105/230 All in favor – passed Junior B – remove no mx / race experience Junior B – change age to 10-14

Advanced women's class (pro-loop) – change to sportswomen – All in favor – passed

B 9 – Move up/down policy - Once a rider has entered a class, they may drop back down only with permission of the board but will not take their points with them. You can move up one class and take 80% of your points any higher then that you need to have board permission – All in favor of addition – Passed

F5 – Sweepers – There must be a minimum of two sweepers with radios on each loop being raced. Sweepers will be issued radios and vests by the head referee conducting the sweeper meeting.

Add: all riders sweeping must have a vest on indicating they are not competing and have been authorized.

Ted Horbaty – make sure riders aren't wearing safety vests while they race – board to police

More sweepers need to be out on the track for youth race and pro race

All in favor – passed

H - 17 - Event Safety - Quiet hours will be from 22:00 to 07:00 daily. Generators and loud music will not be allowed during this time. Anyone caught breaking this rule will not be allowed to race the following day.

Change to: Quiet hours will be from 00:00 to 07:00 daily. Excessive noise / loud music will not be permitted during this time. Anyone caught breaking this rule will be subject to the pit riding policy. If the person is not a rider, the penalty will be assessed to a competitive family member or will be requested to leave the event. Generators are permitted during quiet hours provided they do not produce excessive noise.
