**Event Attendance:** Wags and Whisker's ultimate goal with foster care is to get these dogs adopted. It very important for us to have good attendance at events.

\_\_\_\_\_ I AGREE to bring my adult fosters to THREE adoption events every month. Adoption events are Saturday's 12-4pm at 2156 Pillsbury #155, Chico

\_\_\_\_\_ I AGREE to bring my puppies fosters to ALL adoption events after they reach 8 weeks of age until the puppies are adopted. Adoption events are Saturday's 12-4pm at 2156 Pillsbury #155, Chico.

\_\_\_\_\_ I AGREE to notify Wags and Whisker's Foster Coordinator Raquel at (530) 715-1545 or raquel@wwprca.com if I cannot attend an event.

\_\_\_\_\_ If I continuously fail to bring my foster to the adoption events, I AGREE pay to the FULL adoption fee listed above.

**Return Policy:** Wags and Whisker's has limited space and staff, which makes it very difficult to take back fosters without preparation.

\_\_\_\_\_ I UNDERSTAND that if I must return a foster, I must contact Foster Coordinator Raquel at (530) 715-1545 or raquel@wwprca.com if I can no longer keep this pet.

\_\_\_\_\_ I UNDERSTAND that if I drop off my fosters without making arrangements with Foster Coordinator Raquel at (530) 715-1545 or [raquel@wwprca.com](mailto:raquel@wwprca.com), there will be a **\$50 fee**.

**Adoption Policy:** All adoptions include spay/neuter, microchip, one free vet examination, vaccinations for one year, and a coupon book with over \$400 in savings from Petsmart.

\_\_\_\_\_ I UNDERSTAND that any potential adopter MUST be screened, interviewed and approved by an authorized WAGS AND WHISKER'S PET RESCUE representative. **Wags and Whiskers can decline any application they choose, including that of the foster in this agreement.**

\_\_\_\_\_ I AGREE to let Foster Coordinator Raquel at (530) 715-1545 or raquel@wwprca.com know if prospective adopters may be contacting about adopting the foster dog(s).

\_\_\_\_\_ I UNDERSTAND that no dog can be adopted before being spayed or neutered.

\_\_\_\_\_ I UNDERSTAND that if I choose to adopt my foster, there is no discount for fostering less than 4 dogs.

\_\_\_\_\_ I UNDERSTAND that if I foster a litter of 4 or more puppies, I am able to adopt ONE puppy at a \$150 discount from the full adoption fee, if my adoption application is approved. This discount is only applicable to the foster on the application, NOT any friends or family members of the applicant.

\_\_\_\_\_ I UNDERSTAND that if I foster a litter of 3 or more puppies with a Mom, I am able to adopt ONE puppy or the Mom at a \$150 discount from the full adoption fee, if my adoption application is approved. (Minimum price after discount is \$50) This discount is only applicable to the foster on the application, NOT any friends or family members of the applicant.

\_\_\_\_\_ I UNDERSTAND that if I want to adopt my foster, I must complete the application and payment for the dog. If application is not completed, approved and paid for, other potential adopters can still adopt the dog. Attendance to events is still mandatory if application is not yet approved or paid for.

**Medical Policy:** Wags and Whiskers wants all dogs in foster care to receive the appropriate medical attention. Please call Raquel at (530) 715-1545 or [raquel@wwprca.com](mailto:raquel@wwprca.com) if you believe your foster needs medical attention.

\_\_\_\_\_ I AGREE to honor appointments set by Wags and Whiskers to get spayed or neutered.

\_\_\_\_\_ I AGREE to bring the foster dog to get the vaccinations within a week of the listed dates on the application.

I UNDERSTAND that all basic medical expenses for each foster dog that comes into my care will be covered by WAGS AND WHISKER'S PET RESCUE, provided that an authorized WAGS AND WHISKER'S PET RESCUE representative has approved the medical expenses, and the care is from a WAGS AND WHISKER'S PET RESCUE designated veterinarian. Please call Raquel at (530) 715-1545 or \_\_\_\_\_ [raquel@wwprca.com](mailto:raquel@wwprca.com) if you believe your foster needs medical attention.

I UNDERSTAND that if I choose to go to a vet of my choosing without approval from Wags and Whiskers, I \_\_\_\_\_ may be responsible for the vet bill.

**Foster Supplies and Loaner Items:** Wags and Whiskers can provide all supplies needed for foster care, but as a non-profit with limited resources, we appreciate any help with providing your own items and returning any items loaned from Wags and Whiskers.

I AGREE that any supplies that I am given are used for my foster dog(s) and not for personal use, but \_\_\_\_\_ specifically for the dogs in foster care.

I AGREE to bring back the loaned items listed above within 7 days of the foster dog(s) adoption.

I AGREE to pay a fee for all loaner items not returned on time. Current fees at \$35 per crate, \$5 per bowl, \$5 \_\_\_\_\_ per towel, \$10 per blanket.

**Children Policy:** While Wags and Whiskers does it's best to assess behaviors of our dogs before foster dog placement we cannot guarantee any behaviors of the foster dog around children.

I WILL NOT under any under circumstances leave a child unattended with any dog.

I WILL NOT leave treats around the house when children are present and will be cautious and observant when \_\_\_\_\_ children are eating and the dog is in the room.

I AGREE that if there is a child in the household under the age of 5 the dog must be in a crate or separate room \_\_\_\_\_ while the dog is eating or sleeping to prevent accidents.

I AGREE that children under the age of 13 will not walk the dog unless supervised by an adult.

I UNDERSTAND that whenever a child is in the house with a dog, the child is at risk of being accidentally \_\_\_\_\_ knocked over, scratched or bitten etc.

Should I have **ANY** concerns or feel uncomfortable with a situation between the dog and a child **immediately** \_\_\_\_\_ contact **Raquel at (530) 715-1545**

**Other Pets in Household:** Introducing new dogs into a household can take time and patience. Please be careful when introducing your shelter dog to your household.

I AGREE to separate the foster dog(s) and my personal dog(s) if I notice symptoms such as coughing and \_\_\_\_\_ diarrhea and to contact **Raquel at (530) 715-1545**.

I UNDERSTAND that WAGS AND WHISKER'S PET RESCUE cannot guarantee the foster's behavior with \_\_\_\_\_ cats. Even if the dog has previously been cat friendly, please use caution when introducing a new dog to existing cats in the household. If you need assistance, please do not hesitate to contact **Raquel at (530) 715-1545**.

I WILL NOT leave multiple dogs at home in the same room unattended.

I WILL NOT feed my personal dogs and foster dogs in the same room.

I WILL NOT leave toys and treats laying around the house.

**Caregiving Policy:** Wags and Whisker's wants our fosters to be treated with the best care possible.

I AGREE to provide the dog with exercise, basic obedience training and house-training.

I AGREE to take adequate care of any fostered dog in my care by providing nutritious food, plentiful water, and \_\_\_\_\_ adequate shelter, as well as control of external parasites (fleas and ticks).

I UNDERSTAND that general training information is provided by WAGS AND WHISKER'S PET RESCUE's \_\_\_\_\_ and that training greatly increases a dog's chance of being adopted.

I AGREE to care and love ANY foster dog given to me by (WAGS AND WHISKER'S PET RESCUE) as if it \_\_\_\_\_ were my own.

\_\_\_\_\_ I AGREE to administer any medication given by Wags and Whiskers Pet Rescue to the foster dog.  
 \_\_\_\_\_ I UNDERSTAND that the Rescue ID tag must be worn on the dog’s collar at all times, because this is its link to back to WAGS AND WHISKER’S PET RESCUE. If the dog loses its tag, I AGREE to immediately contact WAGS AND WHISKER’S PET RESCUE for a new one.  
 \_\_\_\_\_ I AGREE to keep each foster dog that comes into my care on a leash when outside my home or my own securely fenced yard.  
 \_\_\_\_\_ I UNDERSTAND AND AGREE that no foster dog that comes into my care will be allowed to run or play off-leash in a dog park or other open public area.  
 \_\_\_\_\_ I UNDERSTAND AND AGREE that I am responsible for the safety of each foster dog that comes into my care, and for the safety of other dogs and people the dog comes into contact with.  
 \_\_\_\_\_ I AGREE to immediately notify **(530) 715-1545** in the event of a missing or injured foster dog. If I do not contact WAGS AND WHISKER’S PET RESCUE and take the animal to the vet, it will be at my own expense.

**Release of Liability**

\_\_\_\_\_ I UNDERSTAND that this document provides for the **release of liability of Wags & Whiskers Pet Rescue**, and its staff on account of the actions of any dog of any breed, which has been released into my care.  
 \_\_\_\_\_ I UNDERSTAND that WAGS AND WHISKER’S PET RESCUE and its staff cannot guarantee actions or disposition of any fostered dog placed into Foster Care with me.  
 \_\_\_\_\_ I UNDERSTAND that although reasonable effort has been made to assess the disposition of each dog released to WAGS AND WHISKER’S PET RESCUE beforehand, the dog may act unpredictably in any given situation, and that I must take necessary precautions to prevent accidents and guard against unpredicted actions by any fostered dog in my care.  
 \_\_\_\_\_ I AGREE that at no time will I allow any fostered dog to be a nuisance to people or other animals.  
 \_\_\_\_\_ I AGREE to keep any fostered dog in my care safely confined in a fenced yard or kennel run or inside a house or garage when the dog is not with me or a member of my family.  
 \_\_\_\_\_ I AGREE that at no time will any foster dog be placed outside on a tie-out (in a yard, in front of cafe, store etc.)  
 \_\_\_\_\_ I AGREE that when off of my property, any fostered dog will be kept on a leash at all times. Bully breeds and large dogs shall never be allowed off leash and shouldn’t go to a dog park even if they are on leash.  
 \_\_\_\_\_ I UNDERSTAND that WAGS AND WHISKER’S PET RESCUE recommends the use of a dog crate for confinement inside the house and requires the use of ID tags on the dog’s collar in accordance with California law.  
 \_\_\_\_\_ **I UNDERSTAND that the ownership of the foster dogs remains with Wags and Whiskers Pet Rescue and that Wags and Whiskers retains the right to remove a foster dog from my care at any time.**  
 \_\_\_\_\_ **I AGREE to let Wags and Whiskers keep a copy of my driver’s license on file.**
