- 1. This is an ARBA Sanctioned Show, by the filing of your entry you indicate your acceptance of all our show rules and the rules of ARBA, which governs this show (sec. 45-46 exhibitors' rules of ARBA).
- 2. This is a Rocky Mountain High Shows Inc. Sanctioned show, by the filing of your entry you indicate your acceptance of all show rules. ROCKY MOUNTAIN HIGH SHOWS INC. PROHIBITS ANY RABBITS UNDER THE AGE OF SIX (6) WEEKS OLD TO BE ON THE PREMISES OF A SANCTIONED SHOW FOR ANY PURPOSE.
- 3. ENTRY FEES: See entry forms for proper fees. All fees are per show per class, per animal. This is a Double Open show. All entries must be <u>completely</u> filled out (Name, complete mailing address, and <u>phone</u>).
- 4. Entries by mail must be postmarked no later than Saturday July 15th. Mail entries to the show Secretary listed on the entry form. Entry fees must accompany your mailed entry. There will be a \$30.00 service charge for all returned checks. Entrants having a returned check may be asked to have cash, money order, or certified funds for future Montrose County Fair Board Rabbit Shows. MCFB reserve the right to call an entrant collect, if their entry is incomplete or unclear.
- 5. No call-in entries will be accepted.
- 6. All rabbits must have a PERMANENT, LEGIBLE EAR MARK in the left ear, or they will be eliminated from the competition.
- 7. All animals showing signs of disease shall be removed from the showroom (sec. 31 show sponsor rules of ARBA).
- 8. **Youth** exhibitors are invited and encouraged to participate in the Open Shows as we are unable to offer any separate Youth Shows or classes. Youth exhibitors must carry their rabbits to and from the judging table.
- 9. Substitutions will be allowed in the SAME BREED, CLASS, VARIETY AND SEX, **ONLY**. Substitutions will be taken at the time when the rabbit is brought to the table to be shown; it is the **exhibitors**' responsibility to advise the show personnel of the changes before judging begins.
- 10. Exhibitors will be responsible for getting their rabbits to the judging tables as soon as the class is called. Rabbits will be called three (3) times. If not on the table after the final call the class will be closed. **NO REJUDGING OF A CLASS**. Please keep your area clean during the show and clean up before you leave.
- 11. All rights reserved to substitute judges in any event. The Show Superintendent reserves the right to make any changes deemed necessary. The Judging order will be posted the day of the show and will not be known prior to the show.
- 12. No one is allowed in the judging area except for show officials and assistants. **Absolutely NO interference with judges or judging will be tolerated**. ARBA provides specific guidelines for protests. Any emergencies or concerns/complaints should be directed to Show Officials. Show Committee decisions will be final. **MCFB RESERVE THE RIGHT TO REMOVE ANY PERSON OR PERSONS CAUSING A PROBLEM.**
- 13. No awards or remark cards will be mailed. Please pick up your cards at the end of the class and awards during the show. Awards for Best of Breed, Best Opposite of Breed, Best in Show, and Reserve in Show will be awarded.
- 14. Absolutely **NO SMOKING** and **NO DOGS** will be allowed in the showroom. Please keep control of MINORS IN YOUR CHARGE. IF YOU OR YOURS ARE CAUGHT IN OFF LIMIT AREAS YOUR ENTRIES WILL BE PULLED. ANY DAMAGES WILL BE AT YOUR EXPENSE. ANY CHILD CALLING 911 OR USING THE PAY PHONE WITHOUT AN ADULT PRESENT WILL BE REMOVED FROM THE SHOWROOM ALONG WITH PARENT OR GUARDIAN AND ALL ENTRIES.
- 15. Montrose County Fair Board, or Montrose County, or the owner, agent, organization or the show facility, or any other related organization will NOT BE HELD RESPONSIBLE for any type of loss or injury due to fire, theft, accident, or providential destruction under any circumstances; to any person, animal, or personal property, (whether owned, borrowed or rented).
- 16. VENDORS ARE WELCOME. There is a \$25.00 Table Setup Fee. Please have your vendors' fee postmarked by July 6th as well. Make checks out to Montrose County Fair Board (MCFB) and mail to the show secretary.
