#### **Working Our Way Past the Pandemic**

In March of 2020, New York went "on PAUSE" to stop the spread of COVID-19. In many ways our communities shut down and 'business as usual' stopped. About a year later, 40% of eligible adults in Onondaga County have been vaccinated against COVID-19 and our businesses and communities are reopening. Masks are still needed. Precautions are still in place. The state budget passed this year takes these things into consideration. The budget included:

- \$800 million for a new COVID-19 Pandemic Small Business Recovery Grant program that will be administered by the Empire State Development Corporation (ESDC). The grants could be used to cover various business costs including payroll; rent or mortgage payments; payment of local property or school taxes, insurance; utilities; personal protective equipment (PPE) necessary to protect worker and consumer health and safety; heating, ventilation and air conditioning (HVAC) or other machinery or equipment costs necessary for compliance with COVID-19 health and safety protocols.
- \$50 million for the COVID-19 Recovery Workforce Initiative to support reengaging those who have been disproportionately impacted by the economic fallout from the pandemic.
- Restores \$69.4 million in local assistance for programs that provide services critical to the wellbeing of New York's children, including childcare, child welfare services, foster care, adoption subsidies, adult protective and domestic violence services.

#### **NYS Fair 2021 is Happening**

The Fair will go on. Assemblyman Magnarelli took part in a press conference with Governor Cuomo announcing that there will be a 2021 Great New York State Fair, although there will be modifications, including limiting capacity to 50%. The Great New York State Fair is the nation's first and oldest state fair, and the largest state fair in the East. Not only is it a major economic boon to our region, but it's also a major part of the community. A few years ago, the Governor and the Legislature led a transformation of the fairgrounds investing over \$100 million to create a facility that could host events throughout the year and would draw people to the area. Since that time, there was record Fair attendance of over 1.3 million people at the Fair in 2019. That was followed by zero in 2020. The hope is to bring a stronger, larger Fair when the pandemic ends.

#### **Robert Congel Honored**

Assemblyman Magnarelli was proud to present a NYS Assembly Proclamation to Suzanne Congel on behalf of her husband, Robert Congel, who recently passed. His son, Stephen, now Pyramid Companies CEO, was also present. Robert was a pioneering entrepreneur who helped to remove "oil city" and the former scrap yard on the south shore of Onondaga Lake, eventually becoming the site of Carousel Center, now known as DestinyUSA, a 2.4 million square foot shopping and entertainment center that is the largest in New York, serving as a key economic driver for the entire Central New York Region. Although controversial at times, Mr. Congel's vision for Syracuse, including not only DestinyUSA, but also Franklin Square and the Clinton Exchange, will last for many years to come.



**Annual Symposium on Energy Studies Transportation**
