Are you in Compliance with the Order?

All STWEC members must comply with the Waste Discharge Requirements (Order) adopted by the Central Valley Regional Water Quality Control Board's (RB) Irrigated Lands Regulatory Program (ILRP). The Order requires that all commercial irrigators in the Central Valley maintain active membership in a sub-coalition, such as STWEC. Active membership requirements include:

- ☐ Current year fully paid STWEC annual membership fee
- ☐ Completion and submittal of an annual Farm Evaluation (2015) to STWEC

The requirements above must be fulfilled no later than Thursday, June 30, 2016 for continued membership in STWEC and ILRP compliance. Revocation of membership may result in hefty fines from the RB for being out of compliance with the Order. In the event the grower would like to reinstate STWEC membership thereafter, membership back dues must be paid and the associated active member forms must be completed.

Nitrogen Management Plan (NMP) Update

As of May 2016, NMP Certification is not required of members irrigating pasture within a groundwater High Vulnerability Area (HVA) that do not apply nitrogen, ie, grower applied nitrogen fertilizer.

STWEC recently received important information from the Central Valley Water Quality Control board regarding the NMP requirements. The Order states that members located within a groundwater HVA must prepare and implement a Certified Nitrogen Management Plan annually. Until this point, members irrigating pasture that do not apply nitrogen were to meet the Certification requirement even though no nitrogen was applied to pasture land by the grower. Fortunately, and rightly so, this is no longer the case. Therefore, only irrigators in groundwater HVA's that actually apply nitrogen are required to complete the Certification requirement.

NMP Self-Certification Training Workshops

STWEC has partnered with various Sacramento Valley subwatershed coalitions in offering a series of Nitrogen Management Plan (NMP) Self-Certification Training Workshops for members categorized within a High Vulnerability Area (HVA) for groundwater. There are 70 STWEC members in need of NMP compliance and are encouraged to participate in a workshop to meet the groundwater quality requirement, if interested in the self-certification compliance option. The workshops are held at no cost to STWEC members and notices are sent to select STWEC members in need of NMP certification in advance of the sessions.

Despite the fact that this requirement must be met by March 2017, workshops will not necessarily be offered on a regular basis. It is advised to complete this requirement as soon as possible. Many of these requirements seem to be an overstep of the original Environmental Impact Report and will at least double the current costs. STWEC, as well as the Sacramento Valley Water Quality Coalition, are working hard to have many of the proposals eliminated or at least reduced in their requirements.

All members are always encouraged to join the bi-monthly board meetings and we appreciate any comments you may have. In addition, you are welcome to comment to the State Water Quality Control Board or the Central Valley Regional Water Quality Control Board.
