SHOW GUIDELINES

PURPOSE

This exhibition is to showcase exclusively the work of Lea County photographers.

CONDITIONS OF ENTRY

This exhibition is open to Lea County residents. The cost per entry is \$5 for non LCCA members and \$3 for members of LCCA.

Exhibitors must own the copyright of all images used in any submitted print. The Center for the Arts and Lea County Photographers Group assumes no liability for any misuse of copyright by the exhibitor. Images produced from materials copyrighted by persons other than the maker are unacceptable.

Photos must not have any watermarks.

Photos must be at least 5" x 7" and either framed or matted. It is recommended that a mat board or foam board be used when mounting photos. Poster board is strongly discouraged.

Any photographers under the age of 18 must provide a signed permission from their parent or legal guardian to enter this competition.

Any photographs that depict a person as the subject matter of the photograph, a model release form must accompany the entry form.

Lea County Center for the Arts and the jurying committee retain the right to reject any image it deems inappropriate for this exhibition.

Photographs entered in the exhibition may be used in publications to promote the photography show and/or the Center for the Arts.

CLASSIFICATIONS

- **Amateur** – black and white, color, film or digital
- **Professional** – black and white, color, film or digital
A professional is defined as anyone who teaches or demonstrates for profit, or sells their work on a regular basis for profit.
- **Cell Phone Photography**
Photographs must be captured using a cell phone, tablet, or any electronic device that does not have a mechanical shutter. Only manipulations allowed are those made possible by applications on the device itself.
- **Computer Enhanced**
Photos that have been significantly altered using computer software. Entry must have a before and after photo matted together.

DEADLINES

Entries will be accepted beginning Tuesday, January 9, 2018, during business hours. All entries must be received by 4pm on Saturday, January 13, 2018. **No late entries will be accepted.**

Opening reception will be held on Friday, January 19, 2018.

The show will end on March 31, 2018. All entries must be picked up by Saturday, April 7, 2018. Any entries not picked up will be considered abandoned and will become the sole property of LCCA. Entries may not be picked up early.

JUDGING AND AWARDS

Entrants will have their submission juried by a panel of judges. Judging will take place prior to the opening reception. Awards of 1st Place, 2nd Place, 3rd Place, and honorable mention will be given in each of the classifications and Best of Show to the overall winner.

All entries will participate in the People’s Choice award. Votes will be tallied at the close of the exhibition and award will be given when the entries are picked up.

SALE OF PHOTOS

Entries displayed may be priced for sale at the price indicated on the Entry Form. If no price is listed or if the entry is marked not for sale, the entry will be marked NFS. LCCA will retain a 25% commission of the sale of the item.
