Mr. Chuck Spangler, of Spangler Engineering, requested that the Board consider entering into an intergovernmental agreement to assist the Tangipahoa Parish Sewer District with the removal of a fallen tree in the Natalbany River adjacent to the Bankston Road Wastewater Treatment Plant. After a lengthy discussion on the cost associated with the removal of the tree and stabilizing the slope after the tree removal, a motion was made by Mr. Wells and seconded by Mr. Vial to enter into an Intergovernmental Agreement to assist the Tangipahoa Parish Sewer District by absorbing the cost of the tree removal along with the Sewer District absorbing the cost of the slope stabilization. An Intergovernmental Agreement will need to be executed by the Drainage District's Legal Counsel including language to hold the District harmless from any damages resulting from the granting of same.
