- -you will use this card when purchasing your (if you forget your card we will have it on file)
- -you will receive a discount on all items in the store. Some products will be discounted more than others (product grown on the farm will be discounted the most (25%), product brought in will be discounted less)
- -you will be able to shop at the stand any day of the week to use your membership amount
- -you can purchase any item, you are not limited to just the items I grow (for example, if you want a box of peaches, you can apply your membership discount and draw from your balance)
- -you will have the entire season to use your membership amount.
- -once you have used all of your balance, you will no longer receive the member discount
- -if you want to purchase another membership during the summer you can at anytime.
- -periodically there will be specialty items that I grow specifically for members. They will be sectioned off and marked for members only!
- -Membership payment in full is required.
- -Any remaining amount on card at end of year is not refundable.
- -We are hoping to open the last week of April.
