The following new Lifetime membership option was approved by the WSCO membership at the Annual Meeting on February 28, 2015, in accordance with article VIII.A. of the WSCO Constitution. A revised membership application form will be available soon.

Lifetime Membership Installment Payment Option Details:

Become a Lifetime member after 3 annual installment payments of \$75 each, due January 1st each year**. WSCO will send an invoice each November, as a reminder of the second and third payments. Final payment must be received within four (4) years of initial application.

Until the membership is paid in full, it will be recorded as a "Pending Lifetime Membership," and will be otherwise treated like an annual membership (expires at end of membership year if dues not received prior to due date).

**Membership begins when Member Application (with first payment) is received by WSCO. If begin date is after Sept 20, 2nd installment will be due the Jan 1st following one full year of membership.

2015 ANNUAL MEETING

The 2015 Annual Meeting of the Welsh Society of Central Ohio was held on Saturday, February 28, 2015 at Worthington Hills Country Club, 920 Clubview Boulevard South, Columbus, Ohio. President Charlotte Prior called the meeting to order at 11:15 am.

President Charlotte Prior welcomed all members to the 2015 Annual Meeting.

Minutes - Kay Caudy moved and Tegwyn Lantz seconded that the minutes from the 2014 Annual Meeting be approved with no changes. The motion was passed.

President's Report - Charlotte thanked Jeanette Muench for doing a wonderful job of organizing this St. David's

Treasurer's Report - Tegwyn Lantz presented the Treasurer's Report. The costs didn't change a lot from the previous year. There were deposits of \$7,238.55 and expenses of \$7,946.29. Laura Gorun moved and Diana Wafe seconded that the Treasurer's Report be approved. The motion was passed.

Audit Report - Homer Williams reported the Audit Committee found the Treasurer's Report to be in order. The Audit Committee consisted of Homer Williams and Jeff Jones.

Youth Eisteddfod – Laura Gorun let everyone know there are a couple of boxes of Christmas cards left. She can bring them to the picnic or she can send them to anyone interested in them, just let her know. Laura indicated that the Christmas card competition is the next competition; if anyone needs Laura to mail them an entry form, please let

Membership - Laura Gorun presented the Membership report. There are a total of 219 members which consists of 152 households. We have lost 10 life members since the last meeting and added 21 new life members. There are 11 members that were annual members last year that haven't renewed this year. The rosters will be mailed out in the

Board of Directors – There are 7 seats on the board with a term expiring in 2018. Four of those seats are held by current Board Members that have indicated they're willing to continue to serve on the board. Ken Evans introduced the members that are up for re-election, they are Kathy Chamblin, Jeff Jones, Patti Jones and Charlotte Prior. Ken asked for nominations from the floor. There were none. Myron Cherry moved and Donna Boyce seconded that the nominations be accepted. The motion was passed. There are 3 open positions to be filled.

Election of Officers - Ken read the nominations for the WSCO officers. They are as follows: President - Charlotte Prior, Vice President - Stacy Evans, Treasurer - Tegwyn Lantz, Corresponding Secretary - TBD and Recording Secretary - Diana Wafe. Donna Boyce moved and Laura Gorun seconded that the officers be approved as presented. The motion was passed.

Acknowledgement of WSCO Board Members no longer on the Board - Charlotte thanked Donna Boyce, Pam Jones and Jeanette Muench for their time on the board. She acknowledged how valuable each of them has been while they served on the board.

Acknowledgement of current WSCO Board Members - Charlotte had the current Board Members stand. Proposed Constitutional Amendments - Laura Gorun explained the changes to the constitution to allow an installment payment plan for those wishing to become life members. There will be 3 annual installment payments of \$75 each due January 1st of each year. WSCO will send an invoice on the 2nd and 3rd year as a reminder that a payment is due. Until the membership is paid in full it will be considered a "Pending Lifetime Membership". Laura Gorun made a motion to approve the amendment, David Jones seconded the motion. The motion was passed.

Old Business - There was no old business.

New Business - There was no new business.

- Laura Gorun said the life member pins are on order and will be sent out to new life members as soon as they're received.
- David Jones let everyone know that Nelson Llewellyn died January 15, 2015.

- Charlotte Prior announced that the picnic would be held on July 18th and she hoped to see everyone there.
- Jeanne Jindra announced that the St. David's Day celebration for southern Ohio is next Saturday. Reservations can be made through tomorrow.
- Stacy Evans announced we won't be having a local Gymanfa in October since the national is here the month before, but we plan to have it again in 2016. [Dragon Tales Editor's NOTE: The Board has since decided to go ahead with a 2015 local Gymanfa] He also announced that he'll be in New York City next weekend for a celebration at the Welsh Church.

<u>From NAFOW (the North American Festival of Wales, Sept. 3-6, 2015, Columbus, OH)</u>

Join us onstage for the Eisteddfod at NAFOW!

We will have six competitions in singing and poetic recitation, all offering cash prizes, on Saturday, September 5, at the Hyatt Regency Columbus. For recitation, two competitions (Adult and Welsh Learner's) involve reciting a poem from memory in Welsh, and English Language Recitation is on offer as well. Hymn Singing involves singing one hymn of your choice in Welsh, while Solo Voice involves singing two pieces, at least one of which must be in Welsh.

We are proud to offer, as part of our Eisteddfod competitions, the David G. Morris Memorial Competition for Solo Voice. This is our signature competition, with the opportunity to win a cash scholarship (\$3,500 US) for travel to compete in the 2016 National Eisteddfod of Wales.

This year's David Morris Competition will be held Saturday, September 5, at the Hyatt Regency Columbus. It is open to singers (residents of the Americas) with some professional training, but whose income is derived only partially from performing. Several David Morris winners have gone on to great success in competing in Wales, including a first-place winner at the 2012 National Eisteddfod in Vale of Glamorgan.

Each competitor is required to sing two pieces from memory (contrasted selections drawn from art song, oratorio or operatic repertoire), at least one of which must be in Welsh. (Competitors should note that participation in the National Eisteddfod of Wales will involve singing in Welsh.)

All of our competitions involve highly qualified adjudicators who provide a very friendly and supportive atmosphere in which to display and develop your own talent in recitation or singing. You will make wonderful new acquaintances, and everyone leaves with the satisfaction of maintaining a great Welsh tradition on behalf of all of North America!

A Welsh folk dancing troupe was formed in 1985, thanks to the efforts of WSCO members Carolyn and Weldon Abels and others. Through the years, the demo teams performed and taught dances at many Celtic and international festivals; private functions including schools, corporations, senior residences and a wedding; the Ohio State Fair; and for WSCO's St. David's Day celebrations (both the Banquet and the Flag-raising) and the Picnic. The folk dancing classes were held for 30 years, and WSCO members taught dancing seminars during the last National here in Columbus.

Sadly, due to dwindling numbers of both demo dancers and class attendees, the last Welsh folk dancing class met on Wednesday, May 20, 2015. The final demo was in April for the local Daughters of Scotland group. Costumes, music and dance instructions are being readied for storage in WSCO's locker, and Donna Boyce sincerely thanks all the people who danced with her since she took over the guidance of the group in 1998 and also the Abels for the dance materials they passed on.

BUT!!! Look for the troupe's name in the 2015 NAFOW program – class attendees voted to use part of their bank account to sponsor the folk dance seminar so, although the classes and demos are over, the influence of the group lives on!

Final Farewell

WSCO Life member Nelson L. Llewellyn, 97, passed away Thursday, Jan. 15, 2015.

Nelson was born Aug. 28, 1917, in Warren, OH, the son of the late Lewis W. Llewellyn and Christine Shoenberger Llewellyn, and was a graduate of Braceville High School and Kent State University.

Nelson served in the U.S. Army Air Corps in the 46th Bomber Group. Before World War II, he was employed by Peerless Electric in Warren and the Goodyear Aircraft Corp. in Akron. After the war he was employed as an industrial engineer at Republic Steel in Warren and Niles, retiring in 1982.

Nelson devoted a large part of his life to music. He studied voice and was a proficient trumpet player.

As a young man, he competed in annual Welsh Eisteddfod voice competitions in Trumbull County and was a proud member of the First Presbyterian Church's Motet Choir for more than 80 years as well as being a frequent soloist.

He performed many solos with the W.D. Packard Band from the mid-1950s through the mid-80s, performed in a myriad of choral groups, oratorios and gymanfas in northeastern Ohio and Pennsylvania, and was honored to be a soloist at the 1976 Bi-Centennial National Gymanfa Ganu in Philadelphia.

He served as the executive secretary of the Welsh National Gymanfa Ganu Association (now the Welsh North American Assoc.) from 1978 until 1998. He was an officer of the St. David's Society of Youngstown and the Niles Gymanfa Ganu Association for many years, as well as being named the society's Welsh Man of the Year in 1990, and was also a member of the board of directors of The Welsh Home in Rocky River, OH. In 1994 he was presented the Heritage Medallion by the National Welsh American Foundation.

Memories of Nelson will be carried on by two daughters and sons-in-law, five grandchildren, and eight greatgrandchildren. Life member Mary Ann Penry, 69, of London, OH passed away Saturday, January 31, 2015.

She was born September 28, 1945 in Chattanooga, Tennessee to the late Earl Thomas and Beatrice (Davis) Smith.

Mary Ann lived as a youth in both Tennessee and West Virginia, where her father was a coalminer. Her mother then took a nursing job in Washington, DC, and it was there that Mary attended high school and met her future husband.

On July 1, 1962 in Silver Spring, Maryland she married Robert Wayne Penry. After their marriage they lived in many states and abroad during her husband's military career.

She was very involved in her church, serving as a teacher of youth, as a librarian, and in the Relief Society Presidency, a women's auxiliary. She was a bookkeeper and tax preparer who was an office supervisor for H&R Block for eight years before starting her own company "Penry Tax and Bookkeeping Service".

She then took a position as a contractor for the Ohio Department of Education, managing the various student accounts at the state level such as FFA, Hero, DECA, etc. She retired in 1994 and moved with her husband to Englewood, Florida where they lived until returning to Ohio in 2013.

Besides her husband, she is survived by two sons and one daughter-in-law, three daughters and sons-in-law, eight grandchildren, two sisters and a brother and sister-in-law.

WSCO member William Evan Ewing, Sr., 84 years old, passed away on Sunday, February 22, 2015.

"Wonderful, wonderful!" was how Bill Ewing would always answer the question, "How are you today?"

Bill was born July 16, 1930, in Springfield, Ohio to Hazel Davis Ewing and his father, Gomer Garmen Davis and his step-father, Kenneth Miles Ewing.

Bill, a lifetime resident of Columbus, was on the Board of Directors for the Buckeyes Boy's Ranch, The Welsh Society of Central Ohio and North Market. He was a 60 year member of The First Community Church and was a volunteer at Riverside Hospital for over eight years.

A talented cook, he ran a catering business and also prepared and served food to the homeless every month. He helped present one of the Welsh cooking seminars during the 1998 WNGGA National in Columbus.

William is survived by his wife of 43 years, Nancy K. Ewiing, two daughters and one son-in-law, one step-son, four grandchildren, and one great granddaughter.

History of Welsh in Columbus Series Beth Ransopher, WSCO Board member and 2015 NAFOW Local Venue Committee member

Welsh Calvinistic Methodist Church

As I continue to research the history of the Welsh in Columbus, I have discovered several more churches with Welsh congregations that I will share in future *Dragon Tales* articles. Documents show that the Welsh established organized religious assemblies as early as 1824 in Columbus. One of the earliest Welsh affiliated churches was the Welsh Calvinistic Methodist Church.

On October 16, 1848, a group withdrew from the Welsh Presbyterian Church (or Union Church) and formed the Welsh Calvinistic Methodist Church. Before a building could be erected, the small congregation held their meetings for a year or more at the homes of Edward Herbert and Edward Reynolds at the corner of Fourth and Long Streets.

In October 1851 a building was dedicated at the corner of Long and Fifth Streets, with a total membership of 28. The lot to build the Welsh Calvinistic Methodist Church was purchased for \$100.00. Members were known to have lived close to the church, in a neighborhood known as 'Welshburg'. Church services were conducted in the Welsh language. The congregation was in favor of temperance and created an organization within the church called "The Band of Hope". An early Welsh custom practiced by the congregation was to arise during the prayer

and turn about and face the door at the back of the church. The custom was discontinued in 1850.

By 1887 the church decided that more space was needed. The congregation merged with the First Presbyterian Church and a new building was dedicated in 1888 at 315 East Long Street (corner of Long and Sixth Streets) to be called the Welsh Presbyterian Church. The new building cost \$30,000.00. In 1888 membership was around 376. By 1919 the congregation would build again and form the Miami Avenue Presbyterian Church.

Today the original Welsh Calvinistic Methodist Church building at the corner of Long and Fifth Streets does not exist as apartment and condominium buildings have been built as part of the downtown Columbus urban renewal project. The neighborhood known as 'Welshburg' along the Long Street corridor between Third and Seventh streets is now part of the Discovery District. The building formerly known as the Welsh Presbyterian Church still stands today in that it was renovated in 2014 to become the community center for the Normandy Apartments across the street.

For those attending the North American Festival of Wales in September, there will be a Welsh history in Columbus table in the marketplace throughout the duration of the Festival. Please stop by to learn more of our local Welsh history.
