Regardless of what happens, we know that God is walking with us. Advent and Christmas were different, but we found ways to focus on the birth of Jesus. Now we are approaching Lent and Easter. Life continues as we prepare to walk through the season of Lent.

We will have an Ash Wednesday service at 7:00 p.m. on Wednesday, February 17. It will be a little different than the last couple of years. I look forward to gathering with you as we begin our Lenten Journey together. In visiting with people, I find some people look forward to the Ash Wednesday service and others choose not to attend. Do you ever wonder why we would participate in an Ash Wednesday service?

Lent begins with Ash Wednesday and ends on Maundy Thursday. It lasts 40 days plus 6 Sundays. This year it begins on February 17 and ends on April 1. During the 46 days of Lent we are invited to prepare ourselves through spiritual renewal. It is an opportunity to reflect on God's love for us and the gift of God's grace. It is a time to remember that "from dust you came and to dust you shall return." Note that Ash Wednesday is about acknowledging that we do come from dust and we will return to dust. It also is a time for prayer, service, and contemplation.

This year I invite you to reflect upon the gift of shalom, the Hebrew word for peace. The word shalom is also interpreted as tranquility, security, well-being, health, welfare, completeness, and safety. This is an opportunity to reflect on your life, knowing that we all sin and make mistakes. It is not just about sin. It is about how we can reach out to make a difference in the lives of others. A question you may ponder is: how can you receive the gift of shalom and then



give it to others?

I leave you with a word from the Gospel of John 14:27. "Peace I leave with you; my peace I give to you. I do not give to you as the world gives. Do not let your hearts be troubled, and do not let them be afraid."

- ⇒ Church groups are allowed to meet at 65% capacity following proper protocols. Signs will be posted at all rooms to indicate capacity allowed.

Christian Education: We spoke about the thank you cards we were sending to everyone involved in the Sunday School Christmas program. We talked about 3rd grade Bibles. We have one 3rd grade child this year. We have extra boxes of crayons that were given to the committee that we would like to put in the back of the sanctuary so children could use them during Church and take them with them when they leave. Stewardship: The Project Open Door Capital Campaign continues as the project open door debt begins to decrease. Very generous donations have put the church in a position to retire the mortgage in 2021. A new round of PPP grants is now available for organizations that had a decrease in revenue of 25% during any quarter in 2020. It was determined that during the third quarter the church experienced a dip of 25.5%. The amount available to the church is approximately \$12,500 and the process will be similar to the previous round of PPP. – Mike Misheski

## GIVING HEARTS DAY TO BE HELD THURSDAY, FEBRUARY 11



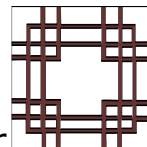

## YEAR-TO-DATE GIVING UPDATE

1-18-2021

2020 ended with operating income totaling \$138,147.57 and operating expenses totaling \$132,836.44 for a net income of \$5,311.13. \$20,000.00 that we received in PPP grant funds helped us to end the year in a positive. Our continued appreciation goes out to all those who volunteer their time and talents to help our church. There are far too many names to mention so thank you to everyone.

In 2020, we started the online giving access from the church web site. This has been very successful. We also have a giving station in the narthex that you can make your donation with a credit or debit card.

Our monthly payment on the building is \$3,146.54. We ended 2020 with the balance on the building fund loan at \$73,830.32 with the initiative to pay off the mortgage loan in 2021. The money designated for our building payment comes from funds that are strictly designated "building fund". To make a contribution to the building fund, write "building fund" on your check or use one of the pew envelopes and mark "building fund". Thank you for your continued contributions.

Per Capita amount for 2021 is \$48.00 for each confirmed member. The unpaid balance at the end of the year is paid out of the church general fund. Please mark on your check or envelope you are contributing to Per Capita.

2020 was indeed a very challenging year. If we give generously to others and for the building of God's kingdom, He will find ways to bless us. We can never outgive God. Jesus tells us to "give, and it will be given to you" (Luke 6:38). Our giving will reap blessings.
