3. One repeat breeding will be granted with the same Dam back to the same Stud dog, if no puppies are produced. If you are not sure that your Dam is bred by the 58th day of the first breeding, an x-ray is required to determine whether or not she is. If she is not pregnant, I do request the following to be sent to me:

- A copy of the x-ray
- A signed and dated statement from your Vet identifying the Dam

One puppy at birth is considered a litter. Failure to raise the litter does not constitute a repeat breeding.
