Q6 Please describe your qualifications for the elected position you seek. Include your main issues, priorities if elected, key endorsements, plus anything else that you'd like our members to know about you and your candidacy.

I am running for Santa Cruz City Council because I believe I have the skills and experience to address the pressing issues facing the City and I will bring a collaborative approach for a positive future for Santa Cruz. I am a biologist and have worked in environmental conservation and restoration for 25 years. My work has included bringing \$30 million in grant funding for environmental and community-benefit projects in the Monterey Bay area. I have honed experience in government policy and finance that I will apply to the priorities of our community. I have a BA in Biology from UCSC and a Masters in City and Regional Planning from Cal Poly San Luis Obispo. I began my career in local government at the Association of Monterey Bay Area Governments in 1993. I founded and was the Executive Director of the Coastal Watershed Council from 1995-2002. I was an Analyst for the City of Santa Cruz City Manager's Office in 2002-2005 and sourced as the Program from 2005 2006.

2003 and served as the regional viatel quality coordinator for the viest coast national manne sanctuary frogram non 2005-2000. I was Director of Conservation for the Big Sur Land Trust from 2006-2012. I have owned my own consulting company helping local government and nonprofits work on environmental and community benefit projects since 2012. My volunteer work includes being Chair of the City Parks and Recreation from 2016 to present. I am currently Chair of the Board of Directors of the Santa Cruz Museum of Natural History and have been a board member since 2011. I also serve on the Santa City Measure E Fiscal Oversight Committee and was previously on the City of Santa Cruz Water Commission. I was previously appointed to the California State Watershed Advisory Committee. My professional background has prepared me to start working as an effective City Councilmember from day one. I believe in working to understand and diagnose issues and then build coalitions that can deliver solutions and create long-term policies that better our community. Transparency and community engagement are important for our residents to keep apprised of what is being proposed and how residents can engage but we also must accomplish projects for our residents. My first priority is setting a clear and transparent path forward on housing availability and affordability for our community. Housing is critical to a thriving community and lack of housing impacts local businesses, schools and the nature of neighborhoods. We have to find solutions for our workforce, for families and seniors, and for those who may need additional support. I believe we must start in our downtown on creating housing in the immediate future. I will work to secure housing funding if available through the state to get our residents housed securely and affordably. I support the Housing Solutions Initiative on the 2018 ballot. I will support and expand our local economy including new sectors such as recreation and adventure tourism, local food and agriculture, technology, arts, alternative transportation, and environmental solutions to climate change including environmental restoration. I believe in investing in developing opportunities for our local business districts such as downtown, the westside, eastside, Seabright and lower Ocean and Beach Flats by reaching out and understanding what is needed by local business. I will also address impacts to local businesses from homelessness and crime through continuing to press for comprehensive approaches for these serious issues in our business districts and checking in to see if City policy and activities are being effective. The place I will work hardest is at the neighborhood level where every resident's life is affected daily. I will be available to neighbors and help them to navigate City Hall to find solutions for issues as well as to chase creative ideas. Neighborhoods are the center of our well-being and I know they are the most important place for engagement and community building. I will meet with neighbors regularly to hear directly how things are going. I believe we are on the verge of a having a better understanding related to homelessness and social services needs in Santa Cruz County and the projects and policy approaches that can be effective. I look forward to being part of the team of elected leaders that will solve one of the most pressing issues not just locally but statewide. We have to solve this issue as it does relate to all of the priorities I have outlined above. I can help do this by making sure City policy is focused on solutions, and that the City, with its partners, are securing state and federal funding as available. Q8 Please tell us about any past or current experiences or involvement you've had addressing LGBTIQ issues or work you've done to support the LGBTIQ community.

My experience working on LGBTQ issues and supporting our community has focused primarily on acting as a private citizen and with my wife through fundraising, support for fair and just policies in letter writing, attending events, and being a mentor for the young people in my life that are LGBTQ. By being out, living a life that values all people, and supporting key issues through advocacy I hope I have contributed to our community.

Q9 What historic political or civil rights struggles are you familiar with that impact LGBTIQ equality?

My wife and I have regularly attended LGBTQ events in Santa Cruz and San Francisco for over 25 years and are members and donors to the Human Rights Campaign and National Center for Lesbian Rights. I am very aware of the issues outlined in the materials and understand how state and federal policy can impact our community members. Local government is a key advocate to protect our citizens against national and state policies that seek to marginalize the LGBTQ community and others in our community. I will be a councilmember that is vigilant in making sure our community and residents are not negatively impacted by national and state laws. We also monitor and try to assist through funding and contacting state and federal electeds regarding immigration and discrimination policy and advocacy.

Q10 What is your philosophy about working with minority communities of which you are not a member, and how will this manifest in your future work with the LGBTIQ community?

I am a member of the LGBTQ community and will continue to work for our community for full equality and respect in all parts of our lives including marriage, housing, employment, healthcare and civil rights.

Q11 Please describe any programs you know of that impact the LGBTIQ community and that are governed by or funded through the elected office you are running for? Include any suggestions you may have for improving these programs.

The City of Santa Cruz is a supportive local government for the LGBTQ community. Direct support for youth and teens is provided through City programs and facilities like the Teen Center. The City also supports the Diversity Center, Family Services Agency, the Santa Cruz AIDS Project, the Homeless Services Center, and Senior Citizens Legal Services. The City's focus on youth services, health care, homeless services and housing, and family services provides a solid safety net for our community. I also am inspired by the work of the Queer Youth task Force, the Safe Schools Project, the Trans*Teen Project, and the Queer Youth Leadership Awards and the Leadership Development Program of QYTF. There are always new and creative programs though that can further help our residents and I will evaluate new opportunities to bring to our community especially in the areas of employment mentorship and LGBTQ youth services.
