# A. AT&T Lease Agreement:

Council discussed the terms proposed by AT& T for modification to the cell site lease and the attached spread sheets prepared by Village President Patrick Betcher outlining the terms of the current. Council agreed to accept a modification of a 5% increase for the first five years and a 10% increase after that. President Betcher also Council that the village received a call from Nextel to decommission the water tower.
