### **Lesson In History Part 23**

#### **A Study In The History Of The Anti-Defamation League (ADL).**

**Introduction.** In [Lesson 22](#) we presented a very short review of the history of British and European nobility and their relationship to the occult and secret societies. It was shown that during the decline of the British Commonwealth in the 19th century, the very secret intelligence networks between England and the United States were developed. It was shown that the sale of illegal drugs paid for that development and operation.

It was shown that the estate of Lord Palmerston was the birthplace of those intelligence organizations. The relationship between Palmerston's intelligence networks and the [Cult Awareness Network](#) of the [Anti-Defamation League](#) was very briefly discussed. The intent of that brief description was to show that the raid on the Branch Davidians at Waco, as well as the assault on the Weaver Family and others, was really the agenda of those international intelligence organizations. These assaults were simply examples of the psychopolitical brainwashing of America to destroy any Christian organization or family that doesn't fit the "politically correct" concept of Christianity.

It is not a matter of the ADL, and the Jews, being concerned for the well-being of Americans in general. Statistics show that although Jews in America constitute less than 3 percent of the population, their membership in cults is inordinately high. Nearly 20 percent of all so-called cult members are Jewish. Further, over 40 percent of the members of Eastern, or Oriental, cults are Jewish. This has become a real problem to Jewish leaders. So the agenda of the ADL and the Cult Awareness Network could possibly be, at least in part, to save their own people from the cults.

Many Americans have become truly alarmed at the direction that our government in Washington has turned. They have finally realized that it is not a matter of the two-party system of politics. Both are guilty of an immoral, un-American, un-Constitutional agenda of returning the United States to a British Commonwealth system of a one world government as envisioned by Rhodes, Carnegie, Palmerston, Rothschild, Montifiore, Warburg, etc.

A recent news release originating with the Los Angeles Times revealed that Americans have lost their trust in the United States Government. In 1964, 62% of Americans trusted the government. In 1992 it dropped to 26% and now, in 1993, our trust in our government has fallen to a mere 13%! At least some of that mistrust in 1993 has come about because of the Waco affair and the Weaver debacle. Undoubtedly, a sizable portion of that mistrust could be directed toward the relationship between a private intelligence organization called the ADL and the United States Government. The revelations that resulted from the raids on the ADL offices in Los Angeles and San Francisco have outraged the average citizen. The national media, at any level, has never before exposed the relationship of a private political spy network with the national law enforcement agencies to the degree that they did in Los Angeles and San Francisco. This writer can only deduce that, once again, this is in the divine providence of God.

The San Francisco and the Los Angeles papers have done an excellent job of revealing the lawlessness of the ADL and the national law enforcement agencies in their spying on private individuals and organizations and freely exchanging intelligence information. This unlawful activity has been going on for decades and the judicial system has always looked the other way.

The nation's major newspapers, other than in the two California cities, have failed to pick up on the sordid details of this unlawful activity. The story has been deliberately ignored by the Jewish-controlled national news. The investigation has been going on now for over eight months. There were arrests made on one ADL undercover agent and one policeman. It is becoming increasingly more obvious that the tremendous power of the ADL and its parent organization, the [B'nai-B'rith](#), is being felt across the country.

The federal government in Washington has said nothing about this matter. The misdeeds on the part of the ADL, the Justice Department, and the law enforcement agencies are of such magnitude that the Attorney General should have ordered a full scale investigation of all of the ADL offices, the B'nai-B'rith, and all law enforcement agencies involved.

It is wrong for the ADL to be allowed an open-door policy into law enforcement offices. It is wrong for the ADL to be allowed to help train law enforcement officers with political disinformation. It is wrong for the ADL to maintain illegal dossiers on specific private citizens. It is wrong for ADL operatives, along with FBI informants, to act as agents provocateur to entice citizens to do something wrong. It is most assuredly wrong for an ADL-associated organization to do what they did at Waco and at Ruby Ridge.

But, as of now, it looks like the investigation is being stonewalled. If this be the case, then we must not let this investigation die. We must continue to expose this un-Christian collaboration which is helping to destroy our once Christian Republic in favor of a world wide commonwealth of political Zionist Democracies. There have been many excellent publications, which have revealed the relationship between the ADL and a world political Zionist conspiracy. But the American people weren't ready to listen. The average church-going American related Zionism to Judaism and if one said anything about Zionism, he was automatically anti-Semitic! But our people are learning that there is a difference. Because of space limitations this lesson will only be able to reveal the more important incidents in history. This lesson is intended to show how this system of politics started, how it developed its political power through crime, became respectable and then used the government to do its dirty work. We will include in the bibliography the titles of some of these writings. If necessary, we will continue in the next lesson.

**The Background of the ADL.** What is the [Anti-Defamation League](#) (ADL) of the [B'nai-B'rith](#)? The ADL was organized, eventually to be a United States 501-C3 tax exempt entity, in 1913. It is a part of the B'nai-B'rith organization. Its Bylaws state that it is a non-profit corporation "designed to eliminate defamation of Jews and other religious and ethnic groups; to advance proper understanding among all peoples; and to preserve and translate into greater effectiveness the principles of freedom, equality and democracy."

But to understand the true purpose of the ADL, we must first understand the origin and purpose of the B'nai-B'rith. That organization was originated in England, in 1841, by Lord Palmerston, who organized the British intelligence system and was, at the time, the Grand Patriarch of the Scottish Rite of Freemasonry. Palmerston was influenced by the Earl of Shaftesbury, Sir Moses Montefiore and the family of the Rothschilds because of the long-standing agreement between Oliver Cromwell and Manachem Ben Israel where together, British nobility and Jewish money were to rule the world. From its inception, the B'nai-B'rith

was to be an intelligence arm of the British Secret Service, then headed by Palmerston. The agreement made between Queen Victoria's government and the Jews was that in exchange for the secret intelligence services of the B'nai-B'rith, Britain would secure a homeland in Palestine for world Jewry.

Past lessons in history have shown how these same people, along with Lawrence Oliphant, Samuel Maitland, John Darby, Scofield and others, penetrated the Christian Church with new doctrines that greatly assisted in obtaining the goal of a homeland for the Jews. When one understands these simple facts of history, it then is easy to comprehend why it is the modern Judeo-Christian churches which appear to be the most adamant against any group or individual whose belief in Christianity is different from the established and approved doctrine. It also becomes easy to understand why the government's charges against these groups and individuals are always centered around their beliefs and not around a specific law.

The B'nai-B'rith was organized in the United States in 1843, during that period before the Civil War when England was fervently trying to recapture this country. The B'nai-B'rith was the secret Masonic lodge that was to be used as a conduit for the flow of intelligence information to and from England. Following the Civil War, they remained active for a period trying to piece together the remnants of the Knights of the Golden Circle, etc. Then, they acquired a new posture and the average citizen became ignorant of their past activities.

However, the original intent of retaining an intelligence- gathering outpost in the United States remained intact. They simply organized the Anti-Defamation League to do the dirty work! Between 1880-1917, there was an intentional immigration of approximately ten million Russian Jews and other peoples from Eastern Europe. This massive immigration was very comparable to the current immigration of similar numbers from Mexico, South America, China, etc. We delivered a message several years ago titled "The Immigration Scam" which, shows how the government allowed that 1880-1917 immigration contrary to the then current immigration laws and quotas. The American people were more vociferous than we are today and they publicly protested the immigration. Thus, the ADL was born. The situation was going wrong just right to suit the One World Order crowd!

The ADL is not a small, obscure, poorly funded organization. It is run by a National Commission which, consists of approximately 151 members headed by a national chairman. During the period between their annual National Commission meetings, there is a National Executive Committee (NEC) which does the work. The NEC is composed of a chairman, usually a senior Rabbi, a vice chairman, the elected officers of the National Commission, the president, executive vice president, and the honorary past presidents of the B'nai-B'rith. In addition, The National Executive Council (NEC) is comprised of the appointed chairmen of all of the ADL standing committees, the president of the ADL Foundation and 15 additional members of the National Commission, who are elected to the NEC by the National Commission.

The ADL is formally associated with the B'nai-B'rith but organizationally only because of the memberships of the president, executive vice president and the honorary past presidents on the National Executive Committee. This very conveniently removes the B'nai-B'rith from public scrutiny when the ADL periodically gets itself into trouble such as the recent San Francisco and Los Angeles exposure of private surveillance efforts.

The ADL is not a membership organization. One cannot join the ADL. One must be invited or nominated to join. This is most significant. Such a procedure allows for a thorough background and security check of any prospective individual. Only when there is an agenda that is to be kept secret from the public, is this procedure required.

The appointed chairmen of the standing committees, who are members of the NEC, represent the divisions of the ADL. There are eight divisions:

***Administration***

***Civil Rights***

***Community Service***

***Communications***

***Development***

***Intergroup Relations***

***International Affairs***

***Leadership***

Of these eight divisions we will study mainly the Civil Rights division. It is here where their surveillance is accomplished. It is the Civil Rights division that interfaces with the national law enforcement organizations. It is the Civil Rights division that funds the paid agents provocateur who covertly defame and "sting" their perceived enemies of Zionism. It is this division that plants disinformation and destabilizes, in the minds of the public, any group or individual they choose.

**The Hegellian Dialectics.** We have many times shown that the recently conceived, and ongoing, immigration into the United States by primarily Mexicans and other South American nationalities, is but another example of the Hegellian Dialectics in action. This technique has been used over and over throughout history with amazing success. Most people simply do not think in terms of intrigue and psycho-politics. When a government, or those who manipulate a government, create a situation such as the current out-of-control immigration problem for a specific political purpose, we can call that the thesis.

Those who perpetrated this action knew positively that such a massive immigration of peoples who do not understand the American or European civilization, would result in problems of crime, drugs, poverty, extensive welfare, etc. This situation is then called the antithesis.

The government is then forced to declare war on that crime, those drug problems, etc. A war of any sort always calls for losses of freedom and liberty. What the United States will look like after this debacle is finished is called the synthesis. The system is so simple but it works every time. Even when a large number of the populace figures it out, it still works because there is so little that can legally be done to stop it. The only way is for a sufficient number (not necessarily 100%) of the "*children of Israel to cry unto the Lord*" ([Judges 6:7](#)). God will see to it that those who offend will be destroyed. In secular terms, our forefathers believed "Rebellion to tyrants is obedience to God."

In this current and ongoing immigration problem there have been many individuals and even well known groups who have tried to stop this onslaught of foreigners who are not compatible with the American civilization. But it has been those who have tried to stop it who have been arrested and even imprisoned for their actions, while the immigrant goes on the dole. It has been the conservative, unnecessarily called a right-wing extremist, who has been at the forefront of trying to stop this massive encroachment on the American soil.

Identically the same thing happened during the massive immigration from Eastern Europe and Russia during the period between 1880 and 1917. It was in this time that the ADL was founded. Around 1900 there was an organization of conservatives, which is now termed by modern writers as the Nativist Anti- Progressive Movement. That movement, considered to be conservative, right wing extremist, fought the massive legal and illegal immigration of these ethnically diverse peoples. The movement grew into a considerable organization and fought the American entrance into World War I as well as the American assistance to the Bolshevik revolution of Russia. Many students of history acknowledge that the then neophyte ADL was already collecting and disseminating intelligence information, interestingly, on both the conservatives and the socialists.

In both of these instances we again see the dialectics in action. Law enforcement, particularly at the national level, encouraged and solicited conservative organizations and individuals to provide intelligence information on these flagrant violations of national immigration law. The ADL used this opportunity to investigate both sides of the situation, collecting intelligence for the best interests of their own people. The ADL gained the confidence of the federal law enforcement agencies by giving these intelligence data to them, just because they were patriotic Americans, of course. The genuine conservatives in the country, because of their church training, considered the ADL as their ally. When it was time to sort out the good guys from the bad guys, it has always been the conservatives who eventually lost. This is obviously so because we need only to look at how much more socialist we are today than we were at the turn of the century!

**The Rise to Power Through Crime.** Since its fledgling start during the great debate over the massive immigration, both legal and illegal, of Russian Jews during the early years of this century, the ADL has continued to become more powerful as each year passes. During their earlier years, they were not as flagrant in hiring paid informants and instigators in investigating and attacking whomever they considered an opponent of Zionism. But their allegiance to political Zionism and the destruction of the Christian way of life becomes obvious when we understand whom they consider, throughout this century, to be their greatest heroes and benefactors.

In 1872, a meeting was held between Baron Maurice de Hirsch and Baron Alfred de Rothschild to organize a Jewish Colonization Association for the purpose of bringing into Canada highly selected Jews from Russia and Eastern Europe. This was at the same time that the massive immigration of Russian Jews into the United States was conceived. Among the many influential Jews who immigrated into Canada was Yechiel Bronfman. This man came from Bessarabia, Romania in 1889. The name Bronfman in Yiddish means "liquorman." The Bronfman family went into the hotel and prostitution business in Canada and, of course, the selling of liquor. It was in this same time period that people with names such as Warburg, Kuhn, Loeb, Lehman, Straus, etc., immigrated into the United States.

In North America, during the earlier part of the 20th century, the American people could not be enticed into using opium, heroin or marijuana. Ordinary alcoholic beverages were used, mostly in moderation, just as they were in Europe. Since our people did not use drugs, a big issue had to be made out of alcoholic beverages. So they created a big war against alcohol and called it "Prohibition"! The Womens Christian Temperance Union (WCTU) was used as the "work horse" to convince our people that Prohibition was the only answer to all of our problems. They received the credit but it was the drug overlords in England, the United States and Canada who paid for it.

Unknown to most Americans, it started in Canada. From 1915 to 1919, Canada passed laws prohibiting the sale of liquor. Of course, the Bronfman family quickly made use of the new Canadian law. Their first endeavor was to join with the Hudson Bay Company, another

firm belonging to the English Oligarchy, to buy the Canadian Pure Drug Company. Using that company as an umbrella, they sold liquor to the Canadians, through the pharmacists, and called it alcohol for "medicinal purposes!"

The Canadian Prohibition lasted only four years until 1919. There had to be a change in their operations. So, on January 6, 1920, the United States passed the Volstead Act, called Prohibition! Now, the Bronfmans could get into crime in really a big way! They concocted a blend of pure alcohol, water, aged rye whiskey, caramel and SULFURIC ACID, called it "Seagram's Chickencock," and smuggled it into the United States.

The Bronfman family bought large unpopulated tracts of land along both sides of the Canadian border and then buried a pipeline across the border. They could now pump their Chickencock liquor into the United States without much danger of being caught! During the period from 1920 to 1930, 34,000 Americans died from liquor poisoning because of the sulfuric acid. After Prohibition ended, the United States government gave the Bronfmans a slap on the wrist by charging them \$1.5 million dollars in income tax.

**The Crime Bosses.** Organized Crime, as we know it, came into being during this period and it was the Bronfmans who started it. Their counterpart in the United States was Arnie Rothstein. He was backed by the investment bankers in New York, who had migrated from Russia and Eastern Europe. It was the Montefiore family who established the Bronfmans in Canada.

Arnie Rothstein was assassinated in 1928 and was replaced by Meyer Lansky. As the drug war against the United States and Canada became more active, Lansky needed assistance and so "Bugsy" Siegel became his partner in crime. The two of them ran the assassination department for the drug war, eliminating anyone who tried to compete with the "Our Crowd" group. Another partner with Meyer Lansky was Morris Dalitz who became known as the leader of the infamous "Purple Gang."

**Becoming Respectable.** Relating this story of the Bronfman clan (along with Lansky, Siegel and Dalitz) with respect to the history of the ADL and the B'nai-B'rith is important because it shows what happens when a family supposedly turns "respectable." It also shows that the attempted destruction of this once Christian Republic by the World Revolutionary Movement (WRM) is still in progress. It also proves that when two ideologies are at war, any resemblance of human dignity and decency is discarded. Evil and decadence are even rewarded.

In 1969, members of the Bronfman family were given, the highest of honors by the Queen of England! The same brothers who developed the "Chickencock" liquor were rewarded for their effort in the drug war against the United States. One brother, Sam, was made a Knight of Grace of the Most Venerable Order of St. John of Jerusalem. His brother Allen, and his son Charles were honored with the highest rank, the Knight of Justice of the Order of St. John. The significance of this is immense in that only those who carry out extremely dangerous missions are thus rewarded. Another son of the Bronfman gang, Edgar, is an honorary vice-chairman of the ADL. He is also President of the World Jewish Congress, which on an international level, does the same work as the ADL in the United States. Obviously, this is much more than being a 501-C3 tax-exempt defender of the Jewish people!

In 1985, the ADL gave its Torch of Liberty award to Morris Dalitz, the partner of Meyer Lansky. After the Prohibition era ended, Morris Dalitz became very involved in syndicated crime in Cleveland and Las Vegas. Dalitz is noted for his huge contributions and other support for the ADL and their agenda.

The ADL Torch of Liberty award was given to Morris Dalitz during the period when Kenneth Bialkin was the League's national chairman. Bialkin was national chairman from 1982 to 1986. It was during this same time frame that Edmond Safra was accused of drug money laundering. Edmond Safra is a Lebanese Jew who owns the Republic National Bank of New York with connections in Syria and Brazil. In 1989 the United States Customs and the Drug Enforcement Agency uncovered the largest drug money-laundering scheme ever recorded. They found Safra's Republic National Bank in the chain of money-laundering that included banks in Colombia and Uruguay. Mr. Bialkin is a very well known attorney on Wall Street. Edmond Safra received the services of Bialkin, along with the ADL, to "disassociate" him from this very serious situation. In return for having done so, Safra gave the ADL a one million dollar tax-exempt gift!

Bialkin arranged for the partnership between Robert Vesco and the drug kings of the Medellin Cartel. That arrangement assured the smooth flow of cocaine and marijuana into the United States. The key to that partnership came about when Bialkin arranged for the takeover of Investors Overseas Service (IOS), a Swiss mutual fund company owned by the Rothschilds. It should be of interest to know that IOS was directly associated with Meyer Lansky. They laundered money for the Lansky syndicate. IOS is or has been associated with the now infamous International Credit Bank (BCI). Again, the BCI was linked to Meyer Lansky through their office manager Sylvain Ferdman.

It was Meyer Lansky who decided to shift their "banking operations" from Switzerland to the Caribbean to make ready for the huge drug shipments from the Medellin Cartel to the United States and it was the ADL and Kenneth Bialkin who made the arrangements.

**The Penetration Into the Christian Life.** The ADL's agenda has always been positive and aggressive but their public statements and their writings reflect a defensive posture. They want the world to believe that anti-Semitism is always the fault of other peoples and not themselves. This "persecution complex" has been very cleverly used to further their agenda. What is the Zionists agenda? It is to destroy Christianity and to replace it with Talmudism, not only in the religious sense but in the secular world. Have they succeeded? To a very great degree they have reached their goals and if we look back in history, we can accurately assess that they have made their greatest gains since the advent of the Anti-Defamation League (ADL). As we continue to study the history of their methods we can readily see that in their minds "the end justify the means."

If any organization, or a group loosely affiliated with a common ideal, intice or coerce Christians to forget Jesus and follow another god, the age-old battle between Christ and antichrist has been won. Such is the case of satan worship.

In 1989, near Matamoros, Mexico, a large satanic burial grounds was found with dozens of mutilated and cannibalized corpses uncovered by police. Because one of the bodies was that of Mark Kilroy, a Texas college student, the Texas State Legislature drafted a law, which increased the penalties for satanic ritualistic crimes. A special session of the Texas Legislature was convened for the purpose. Satan worship is un-Christian and Texas wanted it stopped.

Who was it who came to the aid of satanic worship? It was the Anti-Defamation League of the B'nai-B'rith! They went into their usual frenzied effort to defeat this bill. Their main objection was that the bill was anti-Semitic!


This has been the modus operendi in all of their opposition to anything Christian. The main thrust is opposition to anyone who is anti-Communist. They say that he is anti-Semitic. Communism is diametrically opposed to the concepts of Christianity (Christianity is a pure republican form of government).

Nearly one-third of the ADL budget is spent on defeating anything Christian in nature in our society. The ADL works at the highest level, even the Supreme Court, to create laws banning prayer in schools, banning the Ten Commandments from the walls of schools, and banning Christian displays on public property. At the same time, they now can display the Jewish menorah in these same public locations including at least one of the post offices in New York City! They have succeeded in having city logos with Christian symbols replaced with more secular motifs. They have forced government at all levels to be totally neutral on matters of religion. They have succeeded in getting prayers banned in courtrooms and at graduations. At the same time, they have worked towards the goal of increasing vehemently anti-Christian art to be displayed in public places, all this in the name of freedom of expression. But if that freedom of expression is Christian then it is anti-Semitic and must be abolished!

Our government, through some of its most powerful members, has assisted in this effort. It was Supreme Court Justice Hugo Black, a 33rd degree Mason, who made the following phrase the law of the land: "In the words of Jefferson, the clause against establishment of religion by law was intended to erect a wall of separation between church and state." If we would poll the votes taken by Senators and Congressmen through the years on issues that remove this nation from Christianity, we would find an abnormally high percentage of high-degreed Masons voting in consonance with Hugo Black's dictum. We would further find that the majority of Supreme Court Justices have been high-degreed Masons during this century, since the mass immigration from Russia at the turn of the century. What does this have to do with the ADL and the B'nai-B'rith? It is simply because they are directly associated with the British intelligence services and Freemasonry and have been since 1841.

The ADL, in one of their pamphlets stated, "Since 1948, ADL has filed amicus briefs in practically every major church-state case, consistently arguing for a strict interpretation of the establishment clause..." If that be the case, then why is anti-Semitism excluded? By ADL's own actions and statements anti-Semitism has come to mean anti-Zionism. Zionism is a political movement and has nothing to do with Judaism. Many, if not most, Jewish people have come to know this and they, too, have come to recognize that the ADL is causing them damage.

**Turning to Terrorism.** Once the ADL developed their operations to be highly sophisticated with intensive training by such intelligence services as the Israeli Mossad, they could expand into the more aggressive "dirty tricks" efforts. They began hiring on a full time basis highly trained operatives to act as agents provocateur. As it has turned out, these "dirty tricks" have escalated into physical assaults on property through a splinter group known as the Jewish Defense League (JDL).



**Rabbi Meir Kahane**

The Jewish Defense League (JDL) was supposedly founded by Rabbi Meir Kahane (now deceased). Meir Kahane's former name was Michael King and he was a former undercover agent for the FBI assigned to infiltrate right-wing groups. According to the *New York Times* of June 28, 1971 and as reported by the Institute of Historical Review (IHR), Kahane announced his alliance with the Colombo organized crime family. In reality, though, the real controllers were quite different. According to the biographer of Meir Kahane, Mr. Robert Friedman, a three-person committee controlled the JDL from its founding days. That committee consisted of the Mossad operations chief (later to become prime minister of Israel) Yitzhak Shamir, along with an Israeli parliamentarian Geula Cohen, and the Brooklyn ADL Chairman Bernard Deutch.

The Institute of Historical Review reports that in the magazine *New Solidarity*, dated September 2, 1985, investigative reporters Timothy Pike and Jeffrey Steinberg signed an affidavit which stated that their investigations revealed that the JDL was used as agents provocateur by the FBI as well as the ADL of the B'nai-B'rith! The ADL denied the charges.

The IHR also reports that in the 1970's and early 1980's the JDL owned considerable real estate in the Catskill Mountains of up-state New York. It was here that Allan Goodman, a JDL member who massacred Arab civilians at the Temple Mount in Jerusalem in 1982, received his para-military training. According to the *Times Herald Record* of August 19, 1981 and the *Albuquerque Journal* of August 29, 1975, the JDL was trained at the Catskills camp, called Camp Jedel, by members the Israeli Armed Forces and the U.S. Army Special Forces! The JDL had another camp in Texas Canyon of California. Here the West Coast JDL leader Irving Rubin, along with Mordechai Levy, were trained.

A tactic used to remove the ADL from any possible embarrassment that could result from the JDL militant and terrorist tactics was to publicly denounce them but secretly communicate with them and support them.

An example of this is the bombing of the Washington offices of the Arab-American Anti-Discrimination Committee (AADC) on Nov. 29, 1985. It was a short two weeks before the bombing that Mordechai Levy appeared as the main speaker at a press conference hosted by the Federation of Jewish Organizations of Greater Washington. This organization is known to be associated with the ADL and the B'nai-B'rith. Also, Mordechai Levy had been in frequent direct contact with the Fact Finding Division of the ADL, headed by Irwin Suall, who was an Oxford University trained member of the Socialist International. Remember, Oxford University and British intelligence, starting back in the days of Palmerston, go together. This is but one example of British intelligence and the B'nai-B'rith working together. The purpose of the press conference where Levy was the featured speaker was to present to the press a list of "enemies of the Jewish people" and the AADC was listed in his presentation!

Another bomb went off at the Santa Ana, California office of the AADC, which killed Alex Odeh, the head of the California branch. Seven other people were injured seriously, enough to be hospitalized. Tscherim Soobzokov, a Circassian Muslim was assassinated when a booby-trap bomb exploded and destroyed his home in New Jersey. Again, Mordechai Levy

warned the public that these attacks were going to take place by making public statements of hate against these people and their organization.

The classical example of how the ADL and the FBI work together to hire informants and agents provocateur was the fire- fight that took place the night of June 30, 1968. Although this incident took place 25 years ago, it established an example for all time of how the federal government and a private 501-C3 tax- exempt organization works in collusion for a political agenda. As long as our government responds to the will of special interest groups instead of the genuine will (not the results of rigged polls of the news media) of the American people, these ugly incidents will continue to happen.

Alton Wayne Roberts, a Ku Klux Klan (KKK) member, who was out on bail and awaiting trial for his alleged part in an earlier murder of three civil rights workers, was approached by Adolph Botnick, the regional director of the ADL. Botnick had earlier presented his plan to the Meridian-based FBI Special Agent Frank Watts and the Meridian police detective Luke Scarborough. Botnick's plan was to offer Alton Roberts, and his brother Raymond Roberts, \$69,000 to act as the ADL's agents provocateur.

Apparently the Roberts brothers were leaders of their local Klan chapter. The arrangements with Botnick, evidently was that they would plant a bomb at the home of Meyer Davidson, a local ADL official. The two brothers complied by ordering two fellow members to deliver the bomb and then they informed the FBI of the exact time of the action. An army of police and FBI agents were waiting for them and a local school teacher Kathy Ainsworth was killed and Thomas Terrants took over 70 bullets from the police, but still survived.

The Roberts brothers continued to serve the ADL's agents provocateur program and then when their services were no longer needed, the police placed them in the FBI's witness protection program.

These foregoing incidents are but a very few examples of the type of activities in which the ADL has been involved. These are typical examples and not extraordinary. The official FBI report of Domestic Terrorist Group Incidents in the United States according to group classification for the years 1980-1986 reveals an interesting statistic. The largest number of terrorists incidents were with the Puerto Ricans with 54.8 percent. The second largest group was the so-called left-wing with 22.2 percent. The third largest group was the Jewish terrorists with 17.8 percent. The smallest number of terrorist activities by far was the so-called right-wing group at 5.2 percent!

If we consider the agents provocateur system that has been developed by the ADL to penetrate the right-wing groups, it is highly probable that the 5.2 percent figure is incorrect. Some, if not many, of the terrorist activities credited to the right- wing could be more appropriately charged to the Jewish terrorists.

A lesson to be learned here is that Christian Conservative groups must be extremely careful not to invite anyone thought to be an agent provocateur to their meetings. Don't believe for a second that you can "convert" them. Paul gives us our instructions. *"Be ye not unequally yoked together with unbelievers: for what fellowship hath righteousness with unrighteousness? and what communion hath light with darkness?"* ([2 Cor. 6:14](#))

**Letting the Government do the Dirty Work.** If Christian leaders in the United States made an honest assessment of the decline of Christianity in America, they would undoubtedly find that our churches have decayed more in this century than in any other time in our history as a Christian Republic. Coincidental or not, this is the same period of time as the great immigration from Russia and Eastern Europe. Likewise it was the same

period of time as the rise to prominence of political Zionism. Both of these phenomena were brought about through the encouragement and political intrigue of Lord Palmerston, Benjamin Disraeli, Earl of Shaftsbury, Lawrence Oliphant and the Scottish Rite of Freemasonry.

Within one generation, these immigrants became lawyers, judges, congressmen and senators. Pluralism became a known word within the American society. Laws placed on the books were no longer the black and white of the Bible but the shades of gray of man's interpretation. Our government was becoming more and more Phariseical in its actions. When one thinks like a Pharisee, one becomes a Pharisee. When a government loses its Christian ethic it becomes corrupt and money becomes its god.

**The Building of the Cult Awareness Network.** From the excellent paper titled "*Cult Awareness, ADL Caused Holocaust in Waco*" by Harley Schlanger, we read from a section titled "MK-Ultra: the mother of CAN (Cult Awareness Network) and AFF (American Family Foundation)" the following:

"...After World War II, up through the 1960's and 1970's, the CIA and U.S. military agencies funnelled money through research foundations and universities to study the various effects of torture, brain surgery, hypnosis, sensory deprivation, and hallucinogenic drugs on individuals. These experiments were seeking to perfect methods of mind control. In many cases, the subjects were not volunteers, but were given drugs and otherwise tortured without their permission."

"In fact, CAN and the American Family Foundation are outgrowth of these CIA projects; many of the CIA's pioneer experimenters from the MK-Ultra project are today board members and advisors to CAN and AFF."

"For example, Dr. Louis Jolyon West received CAN's 1990 Leo J. Ryan Award for 'extraordinary courage, tenacity, and perseverance in the battle against tyranny over the mind of man.' Over the course of 30 years, West has experimented on the minds of veterans, prisoners, alcoholics, and drug addicts with hallucinogenic drugs, electroshock, isolation, and small group behavior-control techniques...West continues to be held in high regard among CAN's members, and... is also an advisory board member of the AFF."

"The grande dame of the Cult Awareness Network is Dr. Margaret Singer, who has frequently appeared for news media interviews in the wake of the Waco massacre. Singer, also an AFF advisory board member, got her start as an Army psychiatrist, studying Korean War veterans and prisoners of war. She worked in projects with Drs. Edgar Schein and Albert Biderman, both exposed in John Marks' *The Search for the Manchurian Candidate* as running the parallel military MK-Ultra programs." End of quotes by Harley Schlanger.

It is also of interest to know that it was Dr. Edgar Schein who made a presentation on "brainwashing" at a Washington, D.C. conference in 1962, organized for the Federal Bureau of Prisons by the National Institutes of Mental Health. In his presentation titled "Man against Man: Brainwashing" he stated: "In order to produce marked changes of behavior and/or attitude, it is necessary to weaken, undermine or remove the supports to the old patterns of behavior and the old attitudes. Because most of these supports are the face-to-face confirmation of present behavior and attitudes, which are provided by those with whom close emotional ties exist, it is often necessary to break those ties. This can be done either by removing the individual physically and preventing any communication with those who he cares about, or by proving to him that those whom he respects aren't worthy of it and, indeed, should be actively mistrusted." End of quotes.

The Cult Awareness Network with Margaret Singer and Louis West, utilize this exact system when they kidnap whom they believe to be a member of a cult and that is what happened at Waco that started the sordid story there.

That is exactly what they are doing now with Kathryn Schroeder, one of the members of the Branch Davidians who came out of the complex and was immediately arrested. Twelve of the ex-members of the Branch Davidians are now indicted with various counts including the murder of four BATF agents. They have separated Kathryn Schroeder in an attempt to get her to be a witness for the government against the other eleven. The government must now truly manufacture a case against the Davidians and they haven't learned a thing about the evil of those who work for the Cult Awareness Network of the Anti-Defamation League.

Epilogue. Political Action Committees (PAC), lobbyists and special interest groups have become the major influence in Congress instead of the Bible. The most powerful Political Action Committees and lobbyists in all three branches of government today are the American Israel Political Affairs Committee (AIPAC), The American Jewish Congress, the American Jewish Committee and, although it has a 501-C3 tax exemption, the Anti-Defamation League of the B'nai-B'rith.

Admittedly the Christian Evangelicals also represent a very powerful force in Congress. However, their major effort is not in the removal of homosexuals and lesbians from public office and the return of Christian principles to the American scene. They work toward aid to Israel, the rebuilding of the Temple in Jerusalem and the battle of Armageddon.

With that scenario firmly established it becomes easy to understand why the government, at all levels, has treated so many Christians the way they have. Incidents such as the Gordon Kahl and Arthur Kirk cases, the Midwest farmers crisis of the 1980's, Randy Weaver, and the now infamous Waco affair all have one thing in common. These unofficial PAC's and lobbyists were involved in persuading law enforcement to take action when none was needed.

When a government no longer understands, or even cares, what John the Revelator had to say about the millennium and the end times, in typical Phariseeical attitudes, they will continue to perpetrate more incidents such as the Weavers and Waco.

The government must understand that with every incident there is increased contempt for the government by more and more Christians. It doesn't make any difference, for this argument, whether the belief is Pre, Post, or A-Millennialist. A great part of end-time theology is the separation from government and other institutions that are distrusted. For most, the antichrists and tribulation are here now. There can be "survivalists" and "separatists" in the middle of Los Angeles or New York City. The ranks are growing and are becoming a very powerful culture within the American society. The battle between good and evil continues!
