### Call to order and Pledge of Allegiance

## Approval of March 9th monthly and March 23rd special town board meeting minutes

Young made a motion, seconded by Bruette, to approve the March 9, 2020 and March 23, 2020 Town Board meeting minutes. All Ayes. MOTION CARRIED.

## Treasurer's Monthly Report; 2020 1st qtr. Reconciliation

## A. Monthly Report

The balances for all accounts as of March 31, 2020, are as follows: Checking - \$3,451.65;

Investment Savings - \$302,619.21; and Town CD's - \$ 128,952.33. Total town funds--\$435,023.19. Stands as read subject to an audit with the clerk.

CD's will be coming due next month.

#### B. 2020 1st Otr. Reconciliation

The clerk/treasurer reconciliation report was submitted to the board and reviewed. Larry Katerzynski creates this report with software that was purchased by him. Clerk Gitter questioned whether we should proceed with this same report, and, if so, then we would need to purchase the software. The clerk will check on this.

No officer was in attendance, but Chairman Korth reported on neighborhood boys running around at 4 a.m. and running through the ditches. It was reported to the County Sheriff and they came out to the Town and did a follow up.

## A. Hire seasonal workers for cemetery and set wages

Korth made a motion, seconded by Young, to hire the cemetery seasonal workers; Steven Knapp, John Knapp, Regina Woroniecki-Ziepke, Sierra Knapp, Kiera Woroniecki-Ziepke. All Ayes. MOTION CARRIED.

Korth made a motion, seconded by Young, to set the wages for the head groundskeeper, Steven Knapp, at \$15 per hour and all other workers at \$12 per hour. All Ayes. MOTION CARRIED.

## C. Board of Review-May 21st 4-6pm-Correspondence from Assessor

Reviewed an email sent to the clerk from Associated Appraisal about the upcoming open book and Board of Review meetings and the processing of each due to the Safer at Home order. The Open Book will be by phone appointment, only. The BOR will take place on May 21<sup>st</sup> as scheduled with social distancing procedures in place.

### E. Additional poll worker wages for April 7

The poll workers, as part of their wages, are to receive a lunch provided by the Town. The workers provided their own lunch for the April 7<sup>th</sup> election. The clerk recommends that each worker will receive an additional \$12 in wages for working that day to replace the meal that they didn't receive. <u>Young made a motion, seconded by Bruette, to give the April 7<sup>th</sup> Election workers an additional one-time wage of \$12 each. All Ayes. MOTION CARRIED.</u>

#### F. Roads:

#### 1. Hintz Road Bids

Chairman Korth contacted the Outagamie County Highway Department regarding a proposal for the Hintz Road construction. They gave him an estimate of \$103,599 which does not include the gravel which the Chairman estimates will come in around \$20,000. After some discussion, <u>Young made a motion, seconded by Bruette, to hire the Outagamie County Highway Department to reconstruct Hintz Road from Fuerst Road to the East for an estimate of \$103,599 with an estimate of \$20,000 for a gravel base, time and materials. All Ayes. MOTION CARRIED.</u>

#### 2. Schweitzer Road guardrail & bridge sign update

Chairman Korth stated these are not done.

## 3. 25mph signs on Church Street in Sugar Bush

Supervisor Young stated that the 25 mile-per-hour sign was never replaced on Church Street by the church after road work was done. After some discussion, <u>Young made a motion, seconded by Bruette, to place a 25 mile-per-hour road sign on the Maple Creek side of Church Street in Sugar Bush. All Ayes. MOTION CARRIED.</u>

#### 4. PLSS corners

No PLSS corners will be disturbed with the proposed construction on Hintz Road.

#### G. Town Hall maintenance update

Supervisor Young replaced the light fixtures above the stage with help from Paul Gitter. This was done the Saturday before the Election due to the lights burning out, and replacement had been previously discussed.

### H. Suspension of DNR burning permits until further notice

The DNR has suspended issuing burning permits in DNR controlled areas within Wisconsin. Chairman Korth will continue to issue for Maple Creek on a day to day basis.
