Technical bid should comprise of following documents:

1. The tenderer should have experience of at least three years in fabrication and construction of exhibition stalls/ workshops/symposiums/fashion shows etc.. regarding which certificates, testimonial, bills, payments proof etc. are to be enclosed. One similar completed work costing should not less than Rs.40.00 lakhs from last three years only.
2. The tenderer should have a full-fledged work force, office and workshop for taking up the assignment.
3. The tenderer should have experience of fabrication of Pavilions in any 3 major/metro cities of India. (Attach documentary proof) it will be applicable only for jobs outside Jharkhand.
4. The tenderer must have worked with more than three State or Central Government Departments/Organizations.
5. The tenderer Turnover should be of Rs. 3.0 crore in last three years & should have ISO 9001.2015 Certificate.
6. Self attested copies of income tax return of previous 3 years along with GST registration certificate.
7. Balance sheet for the last three years certified by practicing CA.
8. The tenderer shall submit an affidavit to the effect that it has never been blacklisted.

Other terms and conditions:

- I. If any additional work is executed by the firm on the order of the JHARCRAFT, it will be carried out by the firm at additional cost at approved rates.
- II. The tenderer has to hand over the job assigned in all respect in scheduled time.
- III. The tenderer will have the responsibility regarding safety of life of the persons engaged.
- IV. Jharcraft reserves the right to change, alter/modify the designs/layouts.
- V. Jharcraft reserves the right to include/ exclude agencies as per rules, cancel the contract/order on any reasonable ground/violation of contract etc. for which no compensation will be given.
- VI. Final payment shall be done only after proper verification regarding completion of work by authorized authority .The authorized authority will also check the work from time to time.
- VII. As and when requirement to execute a work arises, rates will be invited from the empanelled agencies. There after work will be awarded at the lowest rates quoted by various agencies to one of the empanelled agencies. Amount of EMD will depend upon the nature & size of work. EMD can be forfeited in case of non-performance of the tenderer.
- VIII. The empanelled agencies will also be responsible for providing accommodation to VIPs, artisans etc., transportation, conveyance, catering, lighting arrangements, audio & visual arrangements, LEDs and other related activities, as per requirement.
