JOB ANNOUNCEMENT HEAVY EQUIPMENT MECHANIC

This is an advanced level position and requires thorough knowledge of automotive, truck and heavy equipment maintenance and repair operations. Duties include but are not limited to; Diagnosis, service and repair various systems that are found on pieces of heavy equipment such as mechanical and computer electronic controls, air brake systems, transmissions, computer controlled automatic and 13-speed manual transmissions, high voltage generators, propane powered equipment, and pneumatic systems. Skills required but not limited to; Gas/Electric welding equipment, use of mechanized tools, jacks, and hoists, read manuals and schematics, rebuild engines and major driveline components.

SUPERVISION

Works under the direct supervision of the Transportation Dept. Manager and under the general supervision of the Tribal Administrator.

PHYSICAL DEMANDS

Stand/work in confined spaces in contorted positions, while working for prolonged periods. While performing duties, the employee is regularly required to stand, walk; use hands to finger, handle, or feel; reach with hands and arms. Employee is frequently required to climb or balance; stoop, kneel, crouch or crawl. Employee must be able to move up to 50 lbs.

MINIMUM QUALIFICATIONS

- 1. High School Diploma or GED
- 2. Commercial Driver's License and insurable through CTA Insurance Carrier.
- 3. Three (3) years of mechanical experience with Large Trucks and Heavy Equipment, or AAS Degree in Heavy Duty Truck/Heavy Equipment Repair may be substituted for two (2) years of experience assisting skilled trades people in repair and maintenance of heavy equipment. A Certificate in Heavy Equipment Repair may be substituted for one (1) year of experience.
