City Council Minutes

July 3rd, 2017

The City Council of the City of New Munich met in regular session at 6:30 p.m., in the City Hall. Jim Poepping, Shawn Duevel, Pat Nathe and Ron Doll were present, Dan Krueger was absent.

On a motion by Shawn Duevel, seconded by Ron Doll and carried the minutes and public hearing minutes from June 5th, 2017 were approved.

The Fire Department had 3 medical calls last month.

Waste /Water Operator, Tom Valerius was present to inform the Council that the chlorine feed pump needs to be replaced. The pump motor for well 6 needs to be replaced, it should still be under warranty. Tom submitted a bill of \$100.00 from Emergency Planning and Community Right-to-Know Act Program (EPCRA) and \$9.98 for filling the generator. He starting discharging the south pond and had problems with the gate valve. He called Rural Water and they will come out see if they can walk him through it. The Minnesota Department of Health had informed Tom that they need to put posts around well 5. The Council decided to keep the old meters to recycle.

Ann Piotrowski, Jaycee member was present to request approval for an On-Sale Liquor License for the JC Jam Event on Saturday August 26th, from 2pm-1am. On a motion by Ron Doll seconded by Pat Nathe and carried the Liquor License was approved.

Fire Relief Treasurer, Karen Timp was present for signatures from the Council and Clerk to ensure there was no conflict of interest.

Christine Carlisle and Wayne Birkholz were present and asked the council if they purchase Cottage Garden and Antiques can they build a house or make one of the buildings a house in the future. They are looking into using the 3 stall garage for sewing and the other building use as an office with bathroom. Their business is an online business. The City Clerk will contact the City Attorney for more information and get back to them.

Ryan Spanier, owner of Shady's was present for renewal of their 2am Liquor License. On a motion by Ron Doll, seconded by Shawn Duevel and carried the 2am Liquor License was approved. Shady's is also planning 2 outdoor events with music on August 5th and 12th from Noon till Midnight. Ryan was informed that they need to use their catering license which means they need to have food available, (this does not mean order off the menu).He was also informed to have the whole area fenced in.

On a motion by Pat Nathe, seconded by Ron Doll, carried and approved, the City Clerk will send out notices for delinquent water/sewer bills.

On a motion by Pat Nathe, seconded by Ron Doll and carried, Wheels Water Service estimates were approved. To clean well 5 and replace pump for \$7692.53 and replace chlorine pump \$1,604.75.

Homeowners rental enforcement tabled till next regular schedule meeting.
