Old Gravois Road Improvements in front of schools- this construction is not scheduled to take place until 2024. The next step is for the district to vacuum excavate all areas that are a conflict with the retaining walls and sidewalks to determine 100% of where the water main is located. Then determine if the main is on private easement or in county right away.
