Introduction to Dr George and Mildred Kingston: Dr. Kingston was born and raised in Washington and attended the University of Washington where he met his wife, Mildred. George received his medical degree from the University of Chicago and Mildred taught at the Universities of Chicago and Illinois. George and Mildred moved to Wenatchee in 1938 and George joined the Wenatchee Central Lions in 1940. He served as a medical officer and participated in the invasions of Africa, Italy and France, landing 2 minutes after the first wave. He received the Legion of Merit for his service to our country. He returned to Wenatchee in 1946 and began his service as a physician and as a Wenatchee Central Lion. He served as club President, as well as Zone Chairman and later, District Governor. In 1970 he received the Distinguished Service Award for Multiple District 19. This is the highest recognition that can be given to an individual Lion in the Multiple District. Dr. Kingston passed away in 1984 and Mildred passed away in 1999. They did not have any children so in their wills, George and Mildred Kingston remembered two churches and the Wenatchee Central Lions with significant gifts. It is through this gift that the Wenatchee Central Lions has established the KINGSTON MEMORIAL FUND, allowing Dr. George and Mildred Kingston to forever continue giving to this community.
