## Release and Waiver of Liability

In Consideration of being permitted to enter the nongeneral spectator area and/or any restricted area (described as including, but not limited to, the racing surfaces, pit areas, infield, approach area and all walkways, concessions and other areas appurtenant to any area where any activity shall take place), or being permitted to practice, compete, affiliate, observe, work for, report, broadcast, officiate, observe, maintain, or for any purpose participate in any way, the undersigned, for himself/herself, his/her personal representatives, heirs and next of kin, acknowledges, agrees, and represents that he/she releases Marlen Motorsports/Bob Bondurant School of High Performance Driving/Wild Horse Motor Sports Park from any and all claims of injury and/or property damage, including that caused by negligence of Marlen Motorsports/Bob Bondurant School of High Performance Driving/Wild Horse Motor Sports Park while on the track property or when attending or participating in any race activities or events, including practices, races, set-up, tear-down, etc.

The undersigned expressly acknowledges that the activities, including participating and/or being in close proximity to racing, are very dangerous and involve the risk of serious injury, disability, and/or death and/or property damage, or other risks not reasonably foreseeable. Acknowledgement is made that any injuries received may be compounded or increased by rescue operations.

The undersigned voluntarily elects to accept the risk connected with entry into the nongeneral spectator area and/or any restricted area and with racing. The undersigned acknowledges and waives Article 18, Section 5 of the Arizona Constitution which provides that the defense of assumption of the risk shall be left to the jury, and herein freely accepts and assumes any and all risk as a condition of entry/participation.

The undersigned hereby releases, waives, discharges and covenants not to sue Marlen Motorsports/Bob Bondurant School of High Performance Driving/Wild Horse Motor Sports Park for any loss or damage on account of injury to the person or property, including death of the undersigned, whether caused or alleged to be caused in whole or in part by the negligence of Marlen Motorsports/Bob Bondurant School of High Performance Driving/Wild Horse Motor Sports Park, or their agents, employees, volunteers.

The undersigned acknowledges that prior to any participation, he/she will inspect the facilities and equipment to be used, and if anything is believed to be unsafe he/she will immediately advise race management and cease further participation.

No oral representations, statements or inducements apart from this written agreement have been made. If any portion of this agreement is held invalid, the remainder shall continue in full force and effect.
