

City of New Munich
City Council Minutes

November 6th, 2017

The City Council of the City of New Munich met in regular session at 6:30p.m., in the City Hall. Jim Poepping, Shawn Duevel, Pat Nathe, and Ron Doll were present, Bryan Kasten was absent.

On a motion by Ron Doll, seconded by Shawn Duevel and carried the minutes and public hearing from October 2nd, 2017 were approved.

Fire Chief, Allen Fiedler was present to inform the Council of three medical calls last month. The Fire Relief meeting will be 11/28/17 at 7pm. The pager high end responding up and running. HydroTesting SCBA cylinders done which needs to be done once every five years. He also informed the Council that the timer is out on the lights to the City Hall and suggests getting a dust to dawn timer, the Council will check with Jesse from LeClaire Electric. Allen submitted bills to be paid, Walmart \$131.38, Computer \$495.94, Hotel Stay \$757.34, MSFDA Membership Dues \$110.00, New Munich Post Office \$70.00 box rent, Pro Hydro Testing \$595.28 and hours for Fire fighters.

Bryan Kasten arrived at 6:38pm.

Waste /Water Operator, Tom Valerius was present to inform the Council on the pond end he sampled and discarded 7th -20th, sampled all 4 monitoring wells and prep pond for the winter. On the water end he sampled for fluoride and bacteria. The water tower backer tripped the mixer in the tower. Tom raised the level in the tower, heat and circulating pump is on. Tom also installed the street sign on Munich Street. In the year of 2018 the city will continue to do testing with DHIA. The city will just need to pay for the sample bottles. He informed the Council that training for the wand and digital meter software will be November 28th and 29th.

On a motion by Bryan Kasten, seconded by Pat Nathe and carried Barb Nathe's building permit was approved.

Ray Painter was present and apologized for walking out at the Public Hearing. He asked the Council what their plans are for the vacant commercial properties the City owns.

Dan Martin was present and asked if the bills will be posted on the website. The Clerk informed him that after the Council approves them they will be added. He also was concerned about the Dead End sign on 7th Ave. It needs to be in a more visible spot. The Council will check into moving the sign.

On a motion by Ron Doll, seconded by Bryan Kasten and carried the LGA money will go into the general fund was approved.

Homeowner's Rental Ordinance was tabled till next regular scheduled meeting.

The City Clerk/Treasure gave her resignation. She will train the new Clerk/Treasure thru year end and also any other training. The City will be posting the job in the official city paper (Melrose Beacon). All resumes must be submitted electronically to ctynewmunich@albanytel.com.
