The purpose of this Reserve Fund is to accumulate moneys to finance the cost or purchase of physical improvements and related preliminary studies and surveys, land or rights in land, any furnishing, equipment, machinery, or apparatus for any physical improvement acquired at the time when such improvement is constructed, reconstructed, or acquired.

BE IT FURTHER RESEOVED, the chief fiscal officer is hereby directed to deposit and secure the moneys of this Reserve Fund in the manner provided by Section 10 of the General Municipal Law. The chief fiscal officer may invest the moneys in the Reserve Fund in the manner provided by Section 11 of the General Municipal Law, and consistent with the investment policy of the Village of Interlaken. Any interest earned or capital gains realized on the moneys so deposited or invested shall accrue to and become part of the Reserve Fund. The chief fiscal officer shall account for the Reserve Fund in a manner which maintains the separate identity of the Reserve Fund and shows the date and amount of each sum paid into the fund, the amount and date of each withdrawal from the fund and the total assets of the fund, showing cash balance and a schedule of investments, and shall, at the end of each fiscal year, render to the Board a detailed report of the operation and condition of the Reserve Fund.

## PUBLIC TO BE HEARD:

DeAnna Hyche of the Broadway Group spoke on the property her group building a 9100 SF retail space at 8453 Main St. Construction duration 90 – 120 days to complete and would like to start in April 2020. The sewer line will need to go behind T. O'Pray property to the Town of Covert Municipal Building to hook into the sewer system. Sewage from the building will go into a holding tank then to manhole. The village does not own pressurized lines. Broadway Group/Retail owner will be responsible for the pressurized line. (Wes to talk to Mary Brewer about cleaning the lines if that becomes an issue). Broadway Group to install a privacy fence along the O'Pray property. Parking will face the building; lighting will automatically shut off one hour after the employees leave. NYS DOT and Army Corps. of Engineers approved ae 43" culvert into the ditch. Broadway Group will install a detention pond on the north side so there would be no runoff.

## Library

WHEREAS, it has always been the policy of the Village of Interlaken to be concerned and to assist Senior Citizens of the Village in any way possible; and

WHEREAS, Section 467 (1b) of the Real Property Tax Law authorizes a municipal corporation to increase the maximum income level by increasing the maximum income and adopting a sliding scale provision; and

WHEREAS, several municipalities in the County have adopted the sliding scale Senior Citizens exemption provision; now, therefore be it

RESOLVED, that the present income eligibility of \$15,000 for the Senior Citizen Exemption established by the Town of Covert also be the same for the Village of Interlaken.

The sliding scale provision adopted as follows:

To \$15,000	50%
\$15,000 - \$15,999	45%
\$16,000 - \$16,999	40%
\$17,000 - \$17,999	35%
\$18,000 - \$18,899	30%
\$18,900 - \$19,799	25%
\$19,800 - \$20,699	20%
\$20,700 - \$21,599	15%
\$21,600 - \$22,499	10%

BE IT FURTHER RESOLVED, that the Villager of Interlaken is adopting this resolution to provide for uniformity and consistency for the administration of the Senior Citizen Exemption in Seneca County.

This Resolution to be effective 02/132020 for 2020 taxation. Unanimously Carried.
